The IFBA operates on a fiscal-year basis, July 1 to June 30, for this award.

The Executive Office urges you to make this subject a top priority. This is a very great honor for the recipient and we are asking all clubs to put forth their effort in submitting these resumes. Surely you all have outstanding fire buffs in your midst that are deserving of this honor. If your candidates name has previously been submitted but not selected, that name may be re-submitted. Only members of IFBA Member Groups and Associate Members are eligible for this award.

Please refer to the attached information regarding this award as provided by the "Fire Buff of the Year" Committee and the list of previous honorees. You may contact me at the below address for any information concerning this award.

It will be greatly appreciated if the nominations and resumes are forwarded to this office at the below address as soon as possible to allow the Fire Buff of the Year Committee sufficient time to study these nominations and make their final selection. Any names that are submitted after June 14 will not be considered.

If your nominee has previously been nominated, but not selected, it is not necessary to complete an entire renomination but rather a letter on official stationary asking that your previous nominee be reconsidered is all the is necessary. Note: Do not submit these resumes to any member of the committee as they must be officially logged in with the Executive Office for the permanent file. Otherwise, they will not be considered. We appreciate your attention and cooperation in this matter.

HENRY N. WILWERS FIRE BUFF OF THE YEAR" AWARD

We, the members of the "Fire Buff of the Year" Committee, would like to take this opportunity to re-emphasize IFBA's interest in the continuation of this Award for many years to come, and to expand somewhat on the information contained in the accompanying letter from the Executive Vice President regarding the nominations for the 2014 Award.

The "Fire Buff of the Year" Award, as it was first known, was established in St. Louis in 1967 to honor the man or woman who best exemplifies the qualities that distinguish a Fire Buff's outstanding achievements in the interests of the IFBA and/or the avocation of Fire Buffing. It has been awarded annually since that time. In April 1976 the name of the Award was changed to further honor its first recipient, Henry N. "Hank" Wilwers.

Any Active Member Group or Associate Member may nominate a member of an IFBA Member Group or an Associate Member to receive the honor. Nominations must be made, in writing, to the Executive Office, as described in the attached letter.

There are no specific "qualifications" or "standards" that must be met. The Committee considers (among other attributes): service to IFBA, service to the local buff club or clubs, service to local fire departments or agencies, service to national fire agencies, assistance to the fire service community in general. The "key word" is, of course, "service." A simple resume, supported by letters of recommendation, is all that is required by the Committee.

If a nominee is not selected, this does not signify a "pink slip" rejection for all time. It simply results from the fact that only one candidate is chosen annually. Should the nominator(s) wish a nominee to be re-considered the next year (or at a later date), a letter to that effect is the only requirement (all files are maintained for a number of years). The Committee does not automatically review these files each year - a re-nomination <u>must</u> be made.

The Committee protects the confidentiality of its deliberations and the identity of the honoree is not made public until the Award Ceremony at the annual convention banquet, nor does the Committee divulge the rationale for its selection, beyond the biographical data presented at the banquet, when all present learn of the accomplishments of the Award winner.

We would like to urge all IFBA Regional Vice Presidents and Member Group officers to make their constituents more aware of this fine opportunity to honor one of their own with this prestigious award. There are many IFBA'ers who are qualified to join the previous honorees who have been recognized for their accomplishments.

IFBA Club Website Recognition Award General Criteria

In an effort to encourage new IFBA Club Websites, and recognize those already in operation, the following guidelines are suggested to be used as the basis of an award.

- 1. Home Page
 - a. Goals and Mission statement of the Club
 - b. Current Club Officers
 - c. Appropriate Club and Affiliated Organizations logos
- 2. Club history
- 3. Membership
 - a. General requirements/obligations
 - b. Printable/electronic membership application
 - c. Number of members
- 4. Home Fire Department(s)
 - a. History
 - b. Apparatus and Station locations
 - c. Current runs/statistics
- 5. Key Radio Frequencies in use in the area
- 6. Club Statistics
 - a. If operate a canteen, current run numbers
 - b. If sponsor a museum, number of visitors, hours of operation, type of exhibits, etc.
 - c. If give awards, what kind, criteria used, recent winners
- 7. Calendar of upcoming local, club and IFBA events
- 8. Abundant photos of Club, Fire Dep't., IFBA activities, etc. throughout the site
- 9. Links to other Fire Buff/IFBA sites
- 10. Ease of navigating the website
- 11. Evidence that the website is kept current

Any Club interested in being considered must self-nominate for this recognition. Others can also suggest club websites, and they will be considered as well. Note that the IFBA will not actively review Club websites; it is the Club's responsibilities to make the initial nomination.

no later than February 15, so that there is adequate time to evaluate the website prior to the next IFBA Convention. Modification to this deadline may be made at the discretion of the Website Award Committee.

If a Club would like to be considered for this award, but for certain club specific reasons they do not include any of the above listed criteria, they should indicate this in their nomination request. We do not want to penalize any club for not including information, if there is a valid reason.

This award will be "virtual." The winner will be noted on the IFBA Website, and the winner will be encouraged to include proper notation on their website, club stationary, etc.

Roman A. Kaminski Memorial Scholarship

The objective of this award is to commemorate the legacy of Roman Kaminski to the IFBA and in so doing provide a scholarship to a worthy individual in the hope of encouraging new individuals to attend the annual convention.

The scholarship will be awarded annually and will cover the cost of the early IFBA convention registration. The cost for this will be assumed by the IFBA, not the host convention committee.

The general guidelines are as follows:

- 1. The award is available to anyone who is a member in good standing of an IFBA Club, or individual IFBA member and who has not attended a previous convention.
- 2. Clubs are encouraged to submit nominations to the Executive Board no later than the Spring Board Meeting.
- 3. Individuals may self-nominate, but these nominations must be accompanied with a letter of support from their club.
- 4. Both the nominating club and the nominee must submit a letter/essay indicating what personal and club benefit he/she hopes to gain from attending the IFBA Convention and why he/she feels deserving of such an award. The nominee's essay should also include his/her fire buffing background and interest.
- 5. Both the nomination letters and the essay from the candidate should be submitted electronically to the Executive Vice President in time for discussion at the Spring Executive Board Meeting.
- 6. The Executive Board shall vote on the winner. If there are no nominations, the Executive Board, at its sole discretion, may award the scholarship to a worthy individual of their choice. But this selection must be in keeping with the general guidelines of encouraging new convention participation.
- 7. To insure that the winner does indeed attend the convention, he/she shall be notified of their selection as soon as possible after the Board Meeting so that the proper convention registration paperwork can be submitted. However, no check for the registration cost will be sent. At the Board meeting at the Convention, the convention committee will verify that the winner has registered and will be attending. Once that has been established, the IFBA will reimburse the convention committee the early registration fee for the winner of the Kaminski Scholarship.
- 8. Should the winner not attend, the IFBA Executive Board may select another worthy individual who is attending and reimburse him/her directly the money he/she spent on the early registration fee.
- 9. Modifications to these submission/notification deadlines may be authorized by the IFBA Executive Board.

Dallas, TX – At approximately 5:48 PM on Thursday, February 27, 2015, Box 4, a quick response Salvation Army Canteen, was requested by Dallas Fire-Rescue to respond to a natural gas leak at a high-rise building in downtown Dallas.

Box 4 was invited to eat dinner with Dallas Fire Station 34 in Pleasant Grove at 6:30 PM, where they would also conduct their regularly scheduled monthly business meeting, when they received the call to respond. Both of their rehab units and twenty one Box 4 members responded to the incident. Engine, truck, and Hazmat crews from Dallas Fire-Rescue rotated through rehab for approximately 2 hours. Civilians were also assisted during the event.

Box 4 is a quick response canteen that supports the fire departments in the Dallas area on a 24/7 basis. They receive a direct page from Dallas Fire-Rescue when their services are requested and have been associated with The Salvation Army since 1963.



The winter of 2014-15 was a typical Chicago winter, always cold and with enough snow to make it interesting. Such was the case when an early February snowstorm dropped over 20 inches of snow in the City. What wasn't typical this winter was the low number of multiple alarm fires, during the first three months of the season, with January and February recording only one multiple alarm for each month.

On December 10, 2014, a 2-11 alarm fire gutted a famed Chicago landmark, The Chicago Firehouse Restaurant,

located just south of the downtown area 14th at and Michigan Avenues. The building was erected in 1906 and housed 104 Engine and Truck 31. The house was closed and sold to a developer

in 1999. The restaurant was opened in 2000 and remained in business until the fire. Workmen doing roof repairs accidentally started the fire causing the entire roof to collapse into the second floor despite the efforts of over 100 firefighters. The owners plan to repair and reopen the structure in the future. While on the subject of historic firehouses, the wrecking ball will not be used on En-

gine 42's old quarters at 228 West Illinois Street, one of the last three-story firehouses that remain standing in Chicago. The structure, completed in 1888, will be a modern office building on the inside while maintaining the classic firehouse exterior. The house was last used by the CFD in 1968.

CFD apparatus updates have been limited to purchases of ambulances from Wheeled Coach. The last of two orders for ambulances have been received and put into service. Twelve 2014 Ford Explorers have been received and assigned to eleven different battalion chiefs and to 6-8-6, Special Operations Dive Master. The Dive Master responds to all water related incidents with Scuba Team 6-8-7. New specifications and bids are being put together for a purchase of new engines and trucks.



The 5-11 Club continues to be very active supporting fire, police and firefighters' union Local 2 events and memorials. Our 21st annual Muster and Flea Market will be held on Saturday, June 20, 2015. Our partners, The Fire Buffs of Illinois will co-sponsor the event. The Muster begins at 8:00 a.m. and will close at 2:00 p.m. with an apparatus parade scheduled for 9:30 a.m. We expect as many

as 60 vendors and visits from some CFD companies. Tours of CFD's Survive Alive House will also be available.

May of 2014 saw the addition of a third rig to our canteen fleet, donated by the MABAS (Mutual Aid Box Alarm Division System) Chiefs Association. The 1991 Ford Panel Van has been repaired, repainted and relettered as SS3 (Support Service Unit). It is quartered with SS2 at Engine 80's quarters on the far southeast side of

the City. It will be used as a resupply vehicle or as a third canteen, as needed. Recently, all three of our rigs participated in Local 2's Annual Toy Parade. Our canteens finished 2014 with 78 respons-

es for service and have had 11 responses for the first two months of 2015.

A new book *Forgotten Fires of Chicago* has recently become available. The 148-page book is written by two friends of the 5-11 Club, Alex A. Burkholder and John F. Hogan, and is available at local bookstores and online.

reserve station in early May. We will host an IFBA Bi-Regional (4 & 6) May 29 and 30. Concluding event will be a grand meal at the Rathskeller restaurant.

An appointed committee chaired by veteran firefighter and administrator John Buckman has started a total rewrite of our original Constitution and bylaws. 

The club served at several long duration incidents towards the end of last year. First, on November 06, the club responded and served at the Dive Rescue recovery operation in the Milwaukee River at Milwaukee and Erie Streets. Then, a week and a half later, the club served for six hours at the 2nd alarm fire at Miller Compressing Company. This location has become the new frequent customer of the Milwaukee Fire Department (in the last eleven years there have been numerous first alarms, (3) 2nd alarms, & (1) 5th alarm). This time fire was burning inside a building containing recycled air bags and interior car upholstery. The Milwaukee County Fire Department sent a Crash Truck (Rescue 8) to assist in the foam operations. Ironically, the M.F.D. was called back to the same location a week later for fire in a scrap pile, 1st alarm companies making quick work of it. Now on all 1st alarm assignments to Miller Compressing, the High Volume Hose Unit and Rescue 8 are automatically sent.

Then, on November 24th, the club was sent to support the M.F.D.'s Heavy Urban Rescue Team (H.U.R.T.) who were performing a high-angle rope rescue on the smokestacks at the WE Energies Power Plant in the Menomonee Valley (alongside the I-43/94 High-Rise bridge). Five private contractors had been performing emissions control testing when an elevator stalled at 120 ft., trapping one of the contractors. The four remaining contractors were trapped further up at the 270 ft. platform. Temperatures were cold, night was falling fast,

the wind was blowing, and snow starting in. The H.U.R.T. Team worked for seven hours to set up a lowering system to safely secure and bring the workers to the ground.

Since then, the big news is the purchase of a new (used) vehicle to replace our beloved and aged E.S.U. 1, a 1971 International/Welch (originally a heavy rescue from Salem, Illinois). On December 29th, the M.F.B.C. took delivery of a 2001 Freightliner MT-45/Grumman Olson, purchased from the

Box 55 Association of Nashville, Tennessee. Formerly known as Rehab 55, this new vehicle will replace our E.S.U. 1 as Rehab 1. A Truck Committee has been established to best determine the spatial functionality needs of the unit and is working with

L.D.V. of Burlington, Wisconsin, to develop a plan to accomplish these needs. In the mean time, club members have been working feverishly to raise funds to support the remodel project. Hats off to Vice President Annie Hermsen for doing an outstanding job of organizing a recent Craft and Bake show on March 22nd. Annie and her team were successful in raising significant funds toward the project.

Milwaukee Fire Department updates

The Milwaukee Fire Department continues to stay busy as the New Year unfolds. A significant greater alarm fire resulted in a Mayday that resulted in a few tense moments for all concerned.

03-31-2015: On the previous night, 03-30, 3rd & 4th Battalion companies responded to a report of smoke

in the hallway of a 3-story ordinary constructed mercantile building (Ground floor contained a bar and dance halls while the 2nd & 3rd floors each contained four apartments) built in 1897. The building at 911-15 S. Cesar Chavez Dr., is located in a neighborhood known for many spectacular fires over the past 30 vears. When companies arrived, they found fire in the front stairwell on the 2nd floor leading to the 3rd floor. Smoke quickly filled the structure as occupants in the 2nd and 3rd floor apartments evacuated the rear stairs or jumped to the roofs of the exposure buildings on sides B & D. 2nd & 3rd alarms were struck to chase the fire in the voids and double ceilings. Crews spent four hours performing

salvage and overhaul on the building, last company going home at 0230 hours.

Fast forward five and a half hours later. A local news crew doing a story on the previous fire for the 8 o'clock news noticed wisps of smoke coming from the 2nd floor windows and called 911. 3rd & 4th Battalion companies returned back to find smoke showing from the 2nd floor windows on the A side. Engine 31 & Truck 1 began to force entry through the board ups while Engine 26 took a line to the 2nd floor and Engine 28 took a line to the 3rd floor. Companies on both floors began to open walls and ceilings looking for the source of the smoke. Truck 1 and Rescue 1 pulled double ceilings on the 2nd floor and found heavy fire rolling across the entire length.

At this point, the fire began to rapidly progress up the front stairs to the 3rd floor where Engine 28 was working, joined by Engine 31. Crews experienced heavy heat, no visibility, and rolling black smoke. Engine 31 transmitted a mayday as both companies struggled to find an exit as the I.C. ordered evacuation of the building and transmitted both the 2nd and 3rd alarms, a minute apart. Engine 31 stumbled down the front stairs under the protection of a line operated by Engine 26 while Engine 28 preparing to bail from a 3rd floor window, found a rear stairwell to exit the building. All companies exited the building and performed a PAR, and then a defensive operation was set up. Trucks 1, 2, & 6 operated their water towers on the A side while five deluge sets and several big lines operated also on the A and C sides. A collapse zone was established for fears that the structure could come down at any minute. Primary concern at this point was keeping fire out of the exposures. Companies were picking up by noon and a demolition crew was tearing the structure down by 1700 hours.

Keen eyed readers will notice a 3rd Battalion Chief responded on the 1st alarm. Since early January, a 3rd Battalion Chief from the Shared Services Initiative now responds as the Accountability Chief. This provides a set of eyes on three sides of the building while Car 18 (Incident Safety Officer) can watch the fourth side and monitor the safety of crews operating both inside and outside of the fire building (s). Readers will also notice West Allis, a Shared Services partner, send their Truck 2 on the 3rd alarm. The M.F.D.'s C.A.D. system has been updated to dispatch the closest, most appropriate resource (regardless of municipal lines).

Greater alarms for 2014 were (10) 2nd alarms and (3) 3rd alarms (17 in 2013 and 33 in 2012). In 2015, we have seen (6) 2nd alarms, (1) 3rd alarm, and (1) 4th alarm so far. Unfortunately, there were ten fire fatalities in 2014 (compared to only 2 the previous year). Busiest companies in 2014 were:

The Repair Shop has been busy as new apparatus arrives. Engines 26 & 32 each received a new 2015 Pierce Arrow XT 1500/500 pumper. Engine 26's 2006 Pierce Dash will be reassigned to Engine 33. Engine 32's 2011 Pierce Arrow XT will be reassigned to Engine 18, their 2008 Pierce Velocity will be reassigned to Engine 16. The former rigs of Engines 16 & 33 will go to reserve status. Meds 7, 14, & 19 are each receiving a 2015 Freightliner/Wheeled Coach ambulance with numerous bump downs planned. Still on order are (3) Ford Taurus sedans, (2) Chevrolet Suburbans, (1) Chevrolet Tahoe, and (1) Ford Explorer for staff personnel. We hope to have pictures of these vehicles as weather cooperates in the next issue.

As we come to a close, hope the weather warms up, everyone is in good health and can enjoy a muster or shoot the latest rig placed in service. Take care and happy buffing in 2015!



WINTER WOES

January is never a kind month for firefighting and the 2015 edition was no exception. Jersey City fire fighters battled their first major fire of 2015 on the bitter cold morning of January 8, 2015. Companies responded to 55 Washburn St. at 0030 hours, a 2.5 story dwelling with exposure close by on either side. A basement fire soon extended to all floors and endangered the adjoining properties.

Deputy Chief Michael Terpak wasted no time in transmitting a 2nd Alarm once the advanced extension of fire was known, With the temperature hovering about 5°, more manpower would be needed so a 3rd Alarm followed. Companies spent the better part of the morning bringing the fire under control. Fire fighters, apparatus and equipment were coated in ice. Car 26, the Gong Club canteen, operated for over 6 hours with a crew of 3 led by Deputy Chief Pat Spellman. Hot chocolate proved to be the beverage of choice that morning!

The last issue of TURN OUT detailed a 5th Alarm at 201-11 New York Ave., Union City, occurring on May 5, 2014. That fire originated in a corner deli and eventually extended down the block destroying five attached 2.5 story row dwellings in addition to the building of origin. Turn the calendar forward by 8 months and 5 days and here we go again! This time the fire was directly across the street from the May fire, originally reported as a mattress fire at 208 New York Ave. at 0256 hours. North Hudson companies arrived to find not only a mattress involved, but a basement fire rapidly extending to the upper floors. Just as they had across the street, fire fighters were confronted with a rapidly extending fire in a row of 2 story dwellings. To complicate matters more, the temperature was now in the low 20s.

Deputy Chief Charles Thomas was in command of the North Hudson companies that morning and immediately transmitted a 2nd Alarm. Smoke inundated the entire area, with boxes transmitted in both adjacent Hoboken and Jersey City stemming from the Union City location. Fire was now into the top floor and cockloft, prompting Chief Thomas to transmit a 3rd Alarm. Fire was soon racing throughout the attached structures. More manpower was needed in an attempt to cut off the fire. A 4th Alarm was then transmitted, bringing Jersey City Eng. Co. 8, 17, Lad. Co. 12 and Batt. 3 to the fire.

All hands worked through the night to contain the blaze to the row of buildings on the east side of New York Ave. Fire was declared under control at 0523 hours, but companies remained on the scene well into the morning. Car 26, the Gong Club canteen, operated for nearly 7 hours, serving 5 gallons of coffee and 7 gallons of hot chocolate to frozen fire fighters.

The following Sunday, January 11, 2015 was a clear, cold day but thankfully the temperature stood above

freezing. A Harrison police lieutenant was patrolling a quiet section of the small town that included a mix of residential and commercial buildings. Shortly after 1500 hours he was flagged down by a motorist reporting a fire in an industrial building at 401 S. 2nd St. This building was the home of Plaque Art Creations, Inc., a 50 year old family owned business, specializing in the manufacture of plaster sculptures, busts and decorative accessories.

What initially appeared to be a small fire rapidly extended, eventually engulfing the entire 1 story square block masonry structure. Harrison's engine and ladder responded, with a mutual aid request for East Newark and Kearny companies. This initial mutual aid response would soon be followed with North Hudson Eng. Co. 1-9, Lad. Co. 4, Batt. 1 and Safety 1. Secaucus Eng. Co. 1 and Tower 2 later joined in the fight as the response grew to 3 alarms. These units had no trouble finding the fire; a towering column of black smoke filled the clear blue sky that afternoon.

An exterior attack was waged for hours, protecting exposures across 3 streets and darkening down the heavy body of fire within the factory. 2 towers, 2 ladder pipes and several handlines were operated to bring the fire under control. Thankfully, the temperature remained above freezing for the duration of the fire. Car 26 operated for 5 hours at this fire, serving 6 gallons of coffee, 3 gallons each of Gatorade and hot chocolate and even a gallon of chili!

The West Hudson portion of the county was again the site of January's last major fire. Saturday,

January 31, 2015 was a cloudless, cold day, but the crystal clear horizon would again be blotted by a plume of ominous, black smoke. Shortly after 1400 hours, a raging fire broke out in a truck repair shop at 23 2nd St., Kearny. The South Kearny industrial area is a peninsula, hemmed by the Hackensack and Passaic Rivers and the Newark Bay. The one story metal clad structure is beneath the Pulaski Skyway, near the South Kearny off ramp. Kearny Eng. Co. 4 is first due in this part of the town and found the building heavily involved upon arrival. The company immediately went into a deck gun, attempting to hold the fire to the building of origin, until the remainder of the Kearny companies arrived from Uptown.

Deputy Chief Robert Osborn assumed command and soon realized that his companies would need a lot more help. The repair shop was burning furiously and threatened the adjacent building housing the field office for the Pulaski Skyway reconstruction project. The Skyway is in the midst of a 2 year rebuilding project requiring the complete closure of its inbound lanes. The last thing motorists needed was a further delay in its reopening.

Kearny Eng. Co. 4, Ladder Tower 2, East Newark Lad. Co. 2 and Jersey City Lad. Co. 9 held the fire to the building of origin. The repair shop, its equipment and several tractors under repair were a total loss. Even more impressive was the ice show resulting from the hours of heavy streams pounding the building. Everything, apparatus, fire fighters and the surrounding environs were covered in ice.

Car 26 operated with a crew of 6 members for nearly 5 hours. Frigid fire fighters enjoyed brief respites from the cold, consuming 3 gallons of coffee, 6 gallons of hot chocolate and 3 gallons of ravioli.

SAD DUTY

Jersey City fire fighters were shocked to learn one of their own, Fire Fighter James Woods, Eng. Co. 14, died suddenly on Christmas Day. Fire Fighter Woods had swapped tours and worked Christmas Eve, but was stricken during family gathering on December 25, 2014. Nearly 200 fire fighters assembled for a full departmental funeral on a frigid December 30, 2014 at St. Joseph's Church in Jersey City.

This sad chain of events was repeated on February 27, 2015 when Fire Fighter Thomas Pilovsky passed away suddenly while on a vacation trip to South Carolina. Again the long blue line gathered at St. Joseph's Church on March 6, 2015 to give Fire Fighter Pilovsky a final salute. Department Chaplain, Rev. James Pagnotta, celebrated the Masses of Christian Burial for both members.

The Gong Club's Car 26 had the privilege of serving fire fighters at both funerals. In addition, the Club served members of the Jersey City Police Department and other police officers on 2 successive Saturdays, December 27, 2014 and January 3, 2015, at Liberty State Park in Jersey City. The park was used as a muster point for officers attending the funerals of the two NYPD officers who were murdered in Brooklyn on December 20, 2014.

Officers first gathered on the Saturday after Christmas for the Funeral of Officer Rafael Ramos and then on the first Saturday of the New Year for the funeral of Police Officer Wenjian Liu. Prior to boarding buses for the trip to Brooklyn, the Gong Club served hot beverages to the officers paying tribute to their fallen brothers.

A DEATH IN THE FAMILY

The Gong Club had its share of tragedy when Member Kenneth Pogan passed away suddenly at his residence on February 11, 2015, a few days shy of his 67th birthday. Kenny was well known in buffing circles and was equally a popular and respected member of the F. D. N. Y. Appointed to the Department in 1973, Kenny served in Squad 3, Eng. Co. 28, Squad 1 and finally aide to Battalion Chief John Calderone in Battalion 22 on Staten Island.

Although his 33 year career ended in 2006, he remained active with a number of F. D. N. Y groups, especially the Friends of the Firefighters organization in Brooklyn. Kenny had been a member of the Gong Club since September 10, 1999. His son, Lt. Kenneth Pogan, Jr., follows in his dad's footsteps, currently assigned to the 15th Division of the F. D. N. Y.

Despite a cold, snowy morning, the long blue line assembled at the Blessed Sacrament Church on Staten Island for the Funeral. The procession was led by Batt. 22, Tower Ladder 79 and Car 26. All Battalion 22 companies assembled at St. Peter's Cemetery on Clove Rd., Staten Island, for a final salute. Rest in peace, Fire Fighter Pogan!

PIERCE RETURNS!

After purchasing American LaFrance and then Crimson / Spartan apparatus in the recent past, Jersey City is again receiving deliveries of Pierce rigs!

Although usually assigned a tower ladder, Lad. Co. 6 had been running with a 2000 E-One 110' rear mount that originally saw service with Lad. Co. 9. However, Lad. Co. 6 is now a tower once again! A 2014 95' Pierce ladder tower was placed in service for the New Year.

The oldest rig in front line service, a 2000 Pierce Saber assigned to Eng. Co. 7, was replaced with a 2014 Pierce 1500 GPM Saber in January 2015. Next on the assembly line is another Pierce for Eng. Co. 15

to replace their 2001 model Pierce Saber.

When not sailing the bounding main, the Marine Unit is assigned citywide as a manpower unit on all working fires. The company had been running with a utility truck, but has now received a 2014 Ford F550 Firematic BRAT equipped with a 250 GPM pump and a 200 gallon tank. With this new addition, the company can now take still alarms in the immediate vicinity of their Liberty State Park quarters.

Secaucus and North Hudson finalized an agreement in March 2015 to swap equipment. North Hudson is giving Secaucus a 1988 32' Monarch fireboat in exchange for Secaucus' 1994 Seagrave 75' tower ladder. Secaucus Tower 2 is expecting delivery of a 2015 Rosenbauer 88' ladder tower imminently. This will be the first Rosenbauer in Hudson County and the first tower for North Hudson.

Our Secretary Ira Cohen received the prestigious Henry N. Wilwers Fire Buff of the Year Award at the Annual IFBA Convention in Dallas Texas on September 6, 2014. On October 15, 2014 we honored Secretary Cohen with a celebration at the Forest Hill Field Club. As a 50-year member of the Bell and Siren Club, Secretary Cohen from a very young age made a commitment to the well being of fire fighters that continues on today. We could not be happier that he was awarded the impressive acknowledgement.

2015 begins with responses to fires both inside and outside of our area

Getting to our call volume, this year, 2015 started slow. Our first call did not come until January 10th 2015 at 7:47 pm with a 2nd alarm fire at 116 Hollywood Ave East

Orange. Thirty-five fire fighters from seven different local departments including Newark responded to the 2-½-story type 5 structure and thankfully rescued 5 children and three adults. One adult was just steps from the front door with horrible burns. With the freezing cold weather and the water from the firefight first responders were slipping and sliding on the ice. We were glad to make the frigid day a bit better. Sadly the second story fire could have been put out without such destruction if there had been smoke alarms but there were none.

As a long tradition we have serviced the urban city of Newark NJ located in Essex County as well as the communities of East Orange, Bloomfield, and South Orange. This year on March 12th 2015 at 9 a.m. our service expanded with a special call to Union County. With that, we went into the town of Elizabeth, NJ for a 3rd alarm fire. On arrival to the fire scene at Keith's Upholstery at 962 Sherman Ave in Elizabeth, many fire fighters from Union County were working diligently. On scene blaring flames were bursting from the commercial building along with very heavy black smoke that was piping from multi purpose two-story building. Several master streams and engine deck guns, along with 2½ -hand lines all worked hard to put the fire out. With the elevated alarm fire fighters from many surrounding towns appreciated our service. We believe life all comes down to the simple things and that makes any day better.

The very next day we had special run to Newark NJ St Patrick's Day Parade. While lined up in a staging area for the parade, we again were called out to 935 South Orange Ave in East Orange, NJ for a third alarm fire. On arrival to Fine Fare Supermarket at that address, smoke was pounding out of vented windows and the roof. The basement fire quickly took off through all floors to the roof and consumed the building. Luckily exposures of nearby building were protected as well as no loss of life.

Only a few days prior on March 9th at 5:14pm we were called to a huge 2nd alarm fire at 45-81 Doremus Ave in Newark, NJ. Four workers were injured at the industrial building fire with one having such horrible burns from the explosion that he was transported to St Barnabas Hospital Burn Center. Driving to the scene, heavy black smoke pillowed out so strongly from the area that it could be seen clearly for miles. Closer to the scene, flames could clearly be seen shooting from the roof and black smoke pouring from the building into the air. Incident command had their hands full

with such a large fire and explosion covering multiple addresses of the commercial type 2 building but with team work 2 ½" hose line ran, tower ladder master stream flowed along with deck guns and most importantly PAR accountability ensured all fire fighters were safe. The building housed a chemical company, and with that reportedly housed numerous chemicals as well as propane. Several tanks were also being stored in the area around the building. With such dangers, we went on scene and provided many fire fighters with nutrition and made the hard work a bit easier.

The risks of lightweight modern construction on the fire ground became very evident on January 21st 2015 at the Avalon Luxury Edgewater Complex. The Seven alarm Fire caused rapid fire spread and collapse occurred leaving 400 families without a home. Edgewater NJ is located in Bergen County NJ which is the largest County in the State of New Jersey. At the height of the fire 35 of Bergen County's 68 Fire Departments were working at the fire. For years, fire fighters have warned of the possibility with such construction and sadly foretold such an incident. A recent UL study found that untreated 2x10 framing wood has a failure time elapse of 18 minutes 30 seconds while engineered lightweight joist only lasts 6 minutes 30 seconds. The mammoth fire was so vast it consumed multiple residential buildings and destroyed a whole complex. Mutual aid was quickly needed. The Box 54 Club called the Bell and Siren Club who answered the call making the day a bit easier.

One of the club's main missions is to collect and preserve artifacts that are significant in the life of a fire department. Moreover, the club owns a collection of hundreds of books, magazines, papers and photographs in both English and French.

Another task of the club is to support the Quebec City Fire Department in staffing the Unit 1299 Canteen during extended operations on major fires. Members respond to second alarms upon request, as well as automatically to all three alarm fires and other events like training exercises and HAZMAT incidents. The unit canteen is Quebec City Fire Department's property but is managed by Club Appel 99.

Day and night, members are ready to hand out free coffee, hot chocolate, Gatorade, cookies and other food to firefighters and other emergency workers. During the winter in Quebec City, nights are very cold and temperatures can reach a frigid minus 30° C.

Recently, the club, which has been planning for a small museum section, took possession of three old fire engines. The engines were a gift from the Quebec City Fire Department.

Special call: 211 hours of consecutive service!

To be on service for nine consecutive days was not an easy task for Club Appel 99's members and the Unit 1299 Canteen.

On November 27, 2014, in downtown Quebec City, a crew of workers were sounding the ground in the backyard of a hospital for a future extension. On one side of the site was the hospital and on the other side, a senior's residence, which was home to about sixty five senior citizens. Suddenly, the crew punched a hole into a pocket of natural gas. As the gas was under high pressure, it began to spew into the air.

A few minutes later, firefighters were on the scene to evaluate the situation.

The hospital's buildings were at a safe distance from the leak, but the senior's residence was less than 150 feet away. At that point, the residents were evacuated from their home.

Time was running out and it was important for the fire department to find a safe solution, but the size of the natural gas pocket was not known.

Several hoses were stretched to douse the area, a metal chimney was built over the pocket to create a « well » and the gas was ignited. Many times the flames blew out. Finally, nine days later, pressure decreased and firefighters and a crew from Alberta sealed the well.

In December, during the cold nights in Quebec City, firefighters, police officers, first responders, ambulance staff, Hydro Québec workers, engineer firms and civil servants have all appreciated Club Appel 99's work very much!

THE ONTARIO FIRE BUFF ASSOCIATES

More than four decades after the club was formed, the *Ontario Fire Buff Associates* is still going strong, serving Canadian fire buffs from coast to coast, and beyond. Founded in 1971, the OFBA today has more than 120 members, from the Maritime Provinces to British Columbia, in the United States, and overseas.

Interestingly, however, Canada's only national fire buff organization traces its origins to an antique fire engine muster in Syracuse, N.Y. In August, 1968, the Society for the Preservation and Appreciation of Antique Motor Fire apparatus in America – better known as SPAAMFAA – held its first antique fire engine parade and muster in Syracuse, not all that far from the Canadian border. Among the hundreds of fire buffs and others with an interest in old fire trucks who attended this milestone event were a number of Canadians.

The next years' Syracuse Muster was even bigger and even more Canadians returned to Syracuse for the second SPAAMFAA Muster. Again, there were handshakes all around, and those present agreed that there should be a similar organization in Canada. The original idea was to form a Canadian chapter of SPAAMFAA-- but as plans progressed we realized the Canadian club would cover a much broader range of firematic interests than just antique apparatus.

So, after a halting start, the Ontario Fire Buffs Association became a reality in the spring of 1971. Our Charter President was Harold McMann of Toronto, who today still proudly carries OFBA membership card No. 1 in his wallet. The club's first membership roster listed 26 names. The fledgling OFBA held its first annual meeting in conjunction with the Ontario Fire Fighters Association convention in Aurora, north of Toronto, in August of that year. Within three years, OFBA membership had passed the 100 mark. Charter member John Holden of Oshawa published the first issue of the club's newsletter, *The Third Alarm* that summer. The OFBA officially became an IFBA affiliate –seemingly appropriate since the International Fire Buffs Association of Fire Chiefs convention in Toronto in 1953. The club changed its name to the *Ontario Fire Buff Associates* in 1979.

And the rest, as they say, is history. It's been an eventful 44 years, with countless meetings and visits to fire departments all over Ontario and in the neighboring United States. While the club has members in most Canadian provinces, the bulk of our membership is concentrated in the Province of Ontario. The OFBA hosted the 1978 International Fire Buff Associates convention in Toronto in 1978, and OFBA members are always in attendance at annual IFBA conventions.

For most of its history, the OFBA's principal activity has been fire department photo tours. Arrangements are made in advance to visit fire departments around the province. Typically, six such tours are scheduled from May into October. Depending on distance (and weather) anywhere from a dozen to 30 or more OFBA members participate in the one or two-day photo tours.

At each station, apparatus is driven out onto the station apron or the street and carefully posed for these serious fire truck photographers. The fast-paced Saturday tour schedule covers anywhere from half a dozen to eight or more stations with the tours extending into late afternoon. Over the years we've hosted more than a few two-day weekend tours to larger metropolitan fire departments. These very sociable club events have taken us as far afield as Ottawa and Windsor, at opposite ends of the province, and to Buffalo and other departments in upstate New York. We've had photo tours at several Canadian Armed Forces bases, as

well as Toronto's Pearson International Airport. For many years, Sarnia member Herb Gallaway was our special events tour organizer, a responsibility assumed by Hamilton OFBA member Ken Buchanan for 2014 and by a committee of the board of directors for 2015.

The OFBA's other big annual event is its Fire Service Collectibles Show and Sale held the morning of the first Saturday in November at the Toronto Fire Services Training Academy in downtown Toronto. This busy fire flea market is followed by

our annual general meeting, which includes a report by our IFBA Region 10 representative.

In 1979 the OFBA acquired a classic 1949 American-LaFrance 700 Series high pressure monitor, one of only two ever built, from the Toronto Fire Department. Once a familiar sight at Ontario musters and parades, High Pressure Monitor No. 2

has been on inactive status of late because of various mechanical problems. After many years of storage at the Box 43 Club's quarters in Hamilton, it's now in the Toronto Fire Services workshop where the mechanical staff are working on it on a spare time basis.

Our *Third A larm* newsletter is published bimonthly, in both electronic and hard copy formats. Members have the option of receiving either, or both. Our very capable newsletter editor is Desmond Brett, who took over, in 2011, from Walt



McCall who edited *The Third A larm* for a remarkable 37 years.

In November 2013, Robert Rupert succeeded Rick Loiselle as OFBA President. Rick served on our Board of Directors for 22 years, 18 as President; from 1991-97 and from 2001 to 2013. Our current executive includes: Robert Rupert, President; Dave Mollison, Vice President; Larry Ward, Secretary; Jim Stronach, Treasurer; Robert Herscovitch, Membership Secretary; Directors Walt McCall, Mike Gough, Des Brett; Past President Rick

Loiselle, and Ian Duke, IFBA Region 10 Vice President.

In 2011, the OFBA hosted a special dinner to mark its 40th anniversary. Among the attendees were several of our original members. Our next major milestone will be our 50th Anniversary in 2021 – which isn't really all that far off. The Ontario Fire Buffs Association is proud of its long, active partnership with the International Fire Buff Associates.
