possible represent the Executive Board in at least one (1) meeting annually in each Region.

Only members of IFBA Member Groups and Associate Members are eligible for this award.

Please refer to the attached information regarding this award as provided by the "Fire Buff of the Year" Committee and the list of previous honorees. You may contact me at the below address for any information concerning this award.

It will be greatly appreciated if the nominations and resumes are forwarded to this office at the below address as soon as possible to allow the Fire Buff of the Year Committee sufficient time to study these nominations and make their final selection. Any names that are submitted after June 15 will not be considered.

If your nominee has previously been nominated, but not selected, it is not necessary to complete an entire re-nomination but rather a letter on official stationary asking that your previous nominee be reconsidered is all the is necessary. Note: Do not submit these resumes to any member of the committee as they must be officially logged in with the Executive Office for the permanent file. Otherwise, they will not be considered. We appreciate your attention and cooperation in this matter.

# HENRY N. WILWERS FIRE BUFF OF THEYEAR" <u>AWARD</u>

We, the members of the "Fire Buff of the Year" Committee, would like to take this opportunity to re-emphasize IFBA's interest in the continuation of this Award for many years to come, and to expand somewhat on the information contained in the accompanying letter from the Executive Vice President regarding the nominations for the 2017 Award.

The "Fire Buff of the Year" Award, as it was first known, was established in St. Louis in 1967 to honor the man or woman who best exemplifies the qualities that distinguish a Fire Buff's outstanding achievements in the interests of the IFBA and/or the avocation of Fire Buffing. It has been awarded annually since that time. In April 1976 the name of the Award was changed to further honor its first recipient, Henry N. "Hank" Wilwers.

Any Active Member Group or Associate Member may nominate a member of an IFBA Member Group or an Associate Member to receive the honor. Nominations must be made, in writing, to the Executive Office, as described in the attached letter.

There are no specific "qualifications" or "standards" that must be met. The Committee considers (among other attributes): service to IFBA, service to the local buff club or clubs, service to local fire departments or agencies, service to national fire agencies, assistance to the fire service community in general. The "key word" is, of course, "service." A simple resume, supported by letters of recommendation, is all that is required by the Committee.

If a nominee is not selected, this does not signify a "pink slip" rejection for all time. It simply results from the fact that only one candidate is chosen annually. Should the nominator(s) wish a nominee to be re-considered the next year (or at a later date), a letter to that effect is the only requirement (all files are maintained for a number of years). The Committee does not automatically review these files each year - a re-nomination <u>must</u> be made.

The Committee protects the confidentiality of its deliberations and the identity of the honoree is not made public until the Award Ceremony at the annual convention banquet, nor does the Committee divulge the rationale for its selection, beyond the biographical data presented at the banquet, when all present learn of the accomplishments of the Award winner.

We would like to urge all IFBA Regional Vice Presidents and Member Group officers to make their constituents more aware of this fine opportunity to honor one of their own with this prestigious award. There are many IFBA'ers who are qualified to join the previous honorees who have been recognized for their accomplishments.

# IFBA Club Website Recognition Award General Criteria

In an effort to encourage new IFBA Club Websites, and recognize those already in operation, the following guidelines are suggested to be used as the basis of an award.

- 1. Home Page
  - a. Goals and Mission statement of the Club
  - b. Current Club Officers
  - c. Appropriate Club and Affiliated Organizations logos
- 2. Club history
- 3. Membership
  - a. General requirements/obligations
  - b. Printable/electronic membership application
  - c. Number of members
- 4. Home Fire Department(s)
  - a. History
  - b. Apparatus and Station locations
  - c. Current runs/statistics
- 5. Key Radio Frequencies in use in the area
- 6. Club Statistics
  - a. If operate a canteen, current run numbers
  - b. If sponsor a museum, number of visitors, hours of operation, type of exhibits, etc.
  - c. If give awards, what kind, criteria used, recent winners
- 7. Calendar of upcoming local, club and IFBA events
- 8. Abundant photos of Club, Fire Dep't., IFBA activities, etc. throughout the site
- 9. Links to other Fire Buff/IFBA sites
- 10. Ease of navigating the website
- 11. Evidence that the website is kept current

Any Club interested in being considered must self-nominate for this recognition. Others can also suggest club websites, and they will be considered as well. Note that the IFBA will not actively review Club websites; it is the Club's responsibilities to make the initial nomination.

### A Christmas Tragedy

Saturday afternoon December 3, 2016 it was chilly, not bad by a New England winters standard. Residents of Cambridge were going about their business and making preparations for the Christmas Holidays. At almost three o'clock 9-1-1 calls flooded the Cambridge Emergency Operations Center, all reporting a fire on Berkshire and Vandine Streets in the Kendall Square neighborhood of East Cambridge. The Public Safety Dispatchers cranked up for action and box 236 was transmitted.

At Engine 5's and Divisions 1's house in Inman Square, the crew was finishing up with the Saturday chores and were ready to wind down. The tones dropped, dispatch with the announcement: "Engine 5, Engine 3, Engine 2, Tower 2, Ladder 3, Rescue 1, Squad 2 and Div. 1. Receiving calls for Berkshire and Vandine Streets".

In the meantime, CPD sector car 1 called in "One to Control I can see a large column of smoke. I will be checking on it." Another car called in "Control, flames are showing on Plymouth St." Car 1 was on scene "step up fire, its



spreading!" Car 1's next transmission would set the stage for a ten-alarm near conflagration - "Step up fire, transformers are popping, there are multiple houses on fire!"

As Division 1 pulled out of quarters Deputy Chief Michael Morrissey reported "Div. 1 to Fire Alarm, we have a large loom-up from quarters. Dispatchers acknowledged and informed Deputy Morrissey that PD was on scene reporting multiple buildings". Engine 5's 2007 Pierce Saber was hot on the Division 1's tail, sirens screaming as they raced down Hampshire Street to the inferno.

Deputy Morrissey arrived on scene and reported "heavy fire showing on both sides of the street, strike second and third alarms!" The uptown Cambridge houses were out the door before the second alarm had finished striking! In neighboring Somerville, the Fire Alarm Operators had been listening in and didn't wait for the third alarm to dispatch Engine 3, Tower Ladder 1 and C3 to fill out the 3<sup>rd</sup> alarm on 236! In just five minutes from striking the box, 9 engine companies, 3 ladders, 2 towers, 1 heavy rescue, 2 paramedic squads and 3 chiefs were all working, or pulling in and getting into action. The flames were having none of it and kept spreading in the tightly packed neighborhood. The companies working were going to need help and lots of it! Deputy Morrissey was "leaning on the hook" and the fourth, fifth and sixth alarms being ordered a mere 4 minutes after the third was struck! Eight minutes later, knowing that mutual aid was coming from father away, the seventh, eighth and ninth alarms were transmitted. The tenth alarm was sounded one hour and seven minutes after the box was struck. On top of all of these companies, special calls were made for three extra engines, 2 ladders and 2 more towers. One of the Towers was coming from the Mass Port Fire Department at Boston's Logan Airport. Ass't Chief (now Acting Chief of Department) and IFBA Secretary Gerard Mahoney was on scene and was directing operations at the fire. By the time the allout was sent on Sunday December 4th at 2038 hrs. 16 buildings were either destroyed or damaged.

Boston transmitted a 6<sup>th</sup> alarm for this Dec. 16<sup>th</sup> fire in Charlestown 6-4161. First due Engine 50 had nothing showing from the outside. They entered the building and reported a heavy smoke condition. Crews battled the fire and sub-zero temps.





Firefighters in Lynn battled this 3<sup>rd</sup> alarm in a three-decker days before Christmas, on December 21st. This fire was a coming attraction for a New Year's Day fire!



On New Year's Lynn and mutual aid companies had their hands full with this four story 22 unit apartment house fire. It needed five alarms worth of manpower and equipment to bring it under control. The fire displaced 65 persons.

Some of the biggest news in these parts is that several smaller cities are adding new heavy rescue companies, or enhancing existing Rescues. Newton has established Rescue Co. 1 and equipped the Company with a 2016 Emergency-One heavy rescue. In neighboring Waltham, Rescue 6 has been de-activated and Rescue Co. 1 established with a brand new Seagrave heavy rescue equipped with more equipment.

We use Periscope for live incident video, which we re-tweet them over the CFPA Twitter page. Combined members followers are around 30,000 as a low estimate.

We currently find this to be the best for incident based verbal communication (as long as you have a connection to internet or Wi-Fi). It covers 85% of the state and also works worldwide. Members have used it to update the group on incidents when on travel or buff trips. We have several channels under the Connecticut Fire Photographers Association and our primary channel is for members only. We do have an open channel for smaller non-fire based incidents, public events and information. The CFPA also operates a private channel for club member's information. We also control the New England Fire Photographer Channel that is open and has a lot of traffic for incidents in MA, RI and CT, and other major events nationwide.

### **OUR NEWSLETTER "The Fire Lens"**

The club produces a newsletter that covers recent events, member's activities and nationally published media, along with sections on improving your skills.

### **Greetings from Central Ohio.**

The year got off to a quick with two greater-alarm fires on January 2<sup>nd</sup>. The first was an early morning 2-alarm apartment fire on the far southeast side. Late that evening, we responded to a 3-alarm fire at a thrift store warehouse. Crews remained on scene until daybreak. On the 4<sup>th</sup>, a crew responded to a 2-alarm apartment fire on the far northeast side. The cause of the fire was determined to be someone disposing of their Christmas tree by burning it in the fireplace. During a cold weather standby (expected wind chills below 0°F) on the 7<sup>th</sup>, we responded to three working fires during the overnight hours. The month ended with a tanker fire at a major freeway interchange. We were unable to assemble a crew to

respond, but thanks to our mutual aid agreement with Union County EMA, they were able to provide rehab support during the incident that tied crews up for several hours. January also included providing support for a recruit training activity and a hockey fundraiser. Box 15 would also like to thank MSC Industrial Supply, who donated tons of sports drink last summer, for their donation of rock salt in January. Their generosity doesn't go unnoticed and is always greatly appreciated.

February provided some relief with only two responses. One was a house fire in Fairfield County, the other was a 2-alarm apartment fire on the far northeast side.

March also proved to be a slow month. Crews responded to a 2-alarm apartment fire on the north side and a fatal 2-alarm fire on the southwest side.

Activity picked up again in April. Crews responded to a mercury exposure hazmat incident at an east side school on the 12<sup>th</sup>. The extremely mild winter of 2017 in Chicago has resulted in only four extra alarm fires since January 1. All were 2-11s or second alarms. In 2016 there were only 34 extra alarm fires for the entire year which broke down to 23 2-11s, eight 3-11s, one 4-11 with a special alarm, and two 5-11s.

In 2016, our canteens responded to 93 requests for service which included numerous responses to S.W.A.T. and H.B.T. incidents for the CPD. The 5-11 Club recently obtained two suburban fire department ambulances that will be converted for use in canteen operations since our two front line canteen rigs are showing their age and becoming costly to maintain. When the new rigs come on line, the Club will keep one of the older rigs as a backup and dispose of the other.

The 5-11 Club continues to add new members with the latest roster showing the Club has 62 regular members, four associate members, one life member and seven honorary members. On a sad note, the Club lost James "Jimmy" Liston due to a long illness. Jimmy was a retired Chicago police officer who was a very active member on the canteen. Jimmy was also instrumental in creating and maintaining pictured ID cards and performing fire radio setups for the Club. Jimmy will be greatly missed for his contributions to the 5-11 Club and his stories and tales of being a Chicago police officer.

One of the 5-11 Club's biggest supporter, Chicago Fire Department Chaplain, Father Tom Mulcrone, has announced his retirement after 30 years of service. In his career, Father Tom has responded to almost 900 alarms, numerous hospital visits, home visits, and funerals. Many of the 5-11 Club members have also been helped by Father Tom in their time of need.

The equipment scene has seen significant change with the assignment of eight squad company units. Squad Co. Nos. 1, 2, 5 and 7 have been operational in the past month. All of the two piece units were built by Rosenbauer America in Minnesota. All units use the Rosenbauer Commander 4000 model for the cab and are powered by 425 H.P. Cummins 12 liter diesel engines. The rescue piece has a 4-door cab with a 19-foot walk-through body with rollup doors and cabinets. These units also have 12 ton front-mounted winches and have hydraulic generators for powering the rescue tools. The second unit for each squad company has the same chassis with a two-door cab. A Zodiac rescue boat is located behind the front seat on a rollout assembly to make for fast deployment at water rescues. The elevated platform is a Cobra with a 55-foot working height. The manual monitor is fed by a 4 inch waterway. These units replace rigs that have been in service for 16 years. Squad Co. No. 7, located at O'Hare Field, is painted in limeyellow to meet airport safety standards. The City units have the traditional black over red paint scheme.

In addition to the new squads, a new mobile command van has been placed into service. The command van (2-7-2) was placed into service this spring on the north side at Engine 112's quarters. The new unit was built by LDV on a Freightliner chassis. The new command van replaces a 2001 Ford diesel and has been outfitted with the latest communication technologies that can link the 9-1-1 Center, police agencies and fire ground personnel. The City is also awaiting the delivery of 18 new Wheeled Coach ambulances, all powered with gasoline engines. Due soon are three new engines from E-One. All the new engines will have 1500 GPM pumps with 500 gallon booster tanks. Four new sedans are also due to arrive soon. The Fast Rescue/Fireboat (6-8-8) that was built by Lake Assault has been disposed of. Lake Michigan can be a hazardous place to be during a storm, and this small boat was not designed to take such a beating. A new, slightly larger boat, from the Department of Homeland Security is due shortly.

On June 17, 2017, the 5-11 Club, together with The Fire Buffs of Illinois, will hold the 23<sup>rd</sup> Annual Fire Engine Rally and Swap Meet. Festivities run from 8:00 a.m. until 1:30 p.m. with a parade starting at 9:30 a.m. The muster is open to the public and admission is free. We look forward to seeing you there. Our friends at the Fire Museum of Greater Chicago will dedicate the Ken Little Fire Museum Library on May 6. This is a great honor for the foremost historian of the Chicago Fire Department. On Saturday, August 12 at 10:00 a.m., the Fire Museum will hold a presentation of the 1967 McCormick Place fire at the Quinn Fire Academy.

Indianapolis Fire Department Chief Ernest Malone has announced the funding for two new station, to be completed March, 2018. NEW station #3 will be located on the same Prospect St., two blocks East of the current spot. NEW station #16 will consolidate #52 and #54, at Hickory/Southport Rd, in Franklin Township. Station #52 will be closed, and Station #54 will be repurposed as the department's Physical Fitness facility.

New equipment approved for 2017/early 2018:

5 new engines (2000 gallon pump capacity)

1 new platform aerial (100 foot)

2 new Ford 550 Rescue squads

1 new tanker (3000 gallon capacity)

1 new Battalion command vehicle

The department's labor contract with IAFF Local 416 has been signed. Contract period spans January, 2017 to December, 2020.

A large passenger bus from Indianapolis Public schools has been repainted with IFD colors and logo for department uses.

Communications will be receiving a new Motorola Premier One CAD system over the next 18-24 months. It will provide automated vehicle locating and updated mapping to modify and correct responses.

The old Fire Headquarters and IFD station 7 have been demolished. They have been moved a few blocks North and East of the former location. Firefighters Credit Union, on the original plot with Headquarters and Station 7, has been removed and now sits in a new building next to Local 416's newly expanded building on Massachusetts Ave.

Our department is in the process of purchasing three aerial drones. Two will be operational and one will be used for training. All pilots will receive required training and will be fully certified.

IFB Rehab Support unit responses for 2016 totaled 236 including Fire, EMS, Law Enforcement and Special calls such as FDIC. In the first four months of 2017, there has been 77 responses, including FDIC. RSU 1, a box ambulance body, has been replaced by a Ford utility rig which was retrofitted by club members and the Fire Department shops to carry coolers and provide electrical service for hot beverages. We will pay for the new identity lettering.

Maintenance continues on our 101-year old Reserve station 12. New overhead gas heaters and portable electric units have replaced the hot water boiler. Water filter for ice machine has been purchased and installed. Storage refrigeration unit failed and was replaced by donated refrigerator from member Jim Williamson's mother. One of the Medic 27 member's family donated surplus laminate flooring and installed it for the Medics' quarters upstairs.

Membership applications and process have been revised. So far in 2017, we had had four new applicants.

2017 committees were assigned by President Byron Jacobs. Names of members present at monthly meetings and signed in will be published in the minutes.

We participated in the downtown St. Patrick's Day parade with our Maxim engine. New name banners were used this year, replacing the older signs that had deteriorated in appearance.

Dennis Chambers also assisted the next week by providing the Maxim for the city's celebration on Monument Circle of three city schools that achieved state basketball championships.

Liability, Auto and Umbrella Liability insurance renewed in March, renewing at close to the same price as the previous year. Our accident and Disability policy will renew in April for the same annual price. Both billings total nearly \$8,000 annually.

Members volunteered for various dates and venues of the Fire Department Instructors Conference in late April at Indiana Convention Center, Lucas Oil Stadium, and multiple HOYS training sites. Daren Feltner arranged for Krispy Kreme donuts at all venues, all days. Surplus bottled water from the training sites was recovered and stored at The Salvation Army EDS building and Reserve station 12 for use during the rest of the year on the RSU's.

Marc Parton and Jerry Traub will be meeting with Region 6 members at Racine, WI in May.

Convention committees are working toward the August 23-26 hosting of the IFBA national convention. Indianapolis looks forward to greeting our friends from all points as we show them the Hoosier Hospitality we can provide.

# FURNITURE FUELS FURIOUS FIRE!

Wednesday, December 21, 2016 and the Christmas Rush was at full speed! With the holiday falling on the weekend, shoppers were racing to finish by Friday. The first full day of winter was sunny and clear with seasonal temperatures. Life's mundane tasks continued as well. North Hudson Chief of Department Frank Montagne was paying his respects at a funeral home when an Alarm was transmitted at 11:30 hours for the Kennedy Furniture store, 1231 Kennedy Blvd., North Bergen. As scant 7 blocks north of the location, Chief Montagne was the first to arrive on the scene.

It's not often that the Chief of Department arrives first on the scene. It's even rarer for the Chief's first report is "Transmit a 2<sup>nd</sup> Alarm"! Heavy smoke, soon visible for miles, was billowing from the large one story structure. The bulk of the fire appeared to be in the rear, which sloped down an incline along 13<sup>th</sup> St. Tower Ladder 3 was directed to take a position on 13<sup>th</sup> St. while first due Ladder 1 had the front of the building on Kennedy Blvd. Companies prepared for a pitched battle as conditions were deteriorating by the minute. Six people in the store exited quickly while first due Engine Co. 1 attacked the fire with their deck gun. A wall of smoke enveloped the entire neighborhood. Roof operations

were soon aborted and a 3<sup>rd</sup> Alarm was transmitted.

Fire roared from back to front of the entire store, bursting out the front display windows with a fury. Ladder Co. 1 was soon caught up in a wave of radiant heat, blistering paint and shattering glass as the crew bedded the aerial and strategically repositioned. A 4<sup>th</sup> Alarm was transmitted bringing mutual aid from Jersey City to the fire. Squad Co. 7 used their Telesqurt and Eng. Co. 9 operated their deck gun to beat back the flames now extending across the sidewalk.

As if the furniture store wasn't enough of a problem, the exposure to the south was a vacant 2 story brick structure loaded with rubber tires! Companies made a stand at that building, preventing an equally heavy fire load from becoming involved. A5<sup>th</sup> Alarm was struck bringing units from Hoboken and Kearny to the fray.

Car 26, the Gong Club canteen, was front and center at 13<sup>th</sup> St. & Kennedy Blvd. A crew of 3 with Member Jim Fay at the wheel served a variety of items to the lunchtime crowd including 8 gallons of hot chocolate, 3 gallons of stew and some 160 bottles of water.

# FATAL FIRE DEVESTATES NEIGHBORHOOD!

A little more than 10 weeks later, a conflagration tore through the fabric of the same neighborhood. Although this next fire was in Union City, the building of origin sat a mere 2 blocks from the furniture store. At 01:02 hours on Saturday, March 4, 2017, North Hudson Regional Fire received


numerous calls reporting a fire at 1401 Summit Ave. Battalion 1, Batt. Chief Mark Lorenz, arrived to a blanket of smoke so thick, he couldn't even determine the size of the structure involved. Occupants were fleeing for their lives, but reported that other people were trapped. Chief Lorenz transmitted a 2<sup>nd</sup> Alarm, ordered ground ladders set up and then transmitted a 3<sup>rd</sup> Alarm! The fire building was a 3-story frame occupied tenement, with similar buildings to the north. A huge volume of fire was now raging in 3 buildings, fanned by high winds in the frigid 21°night. Ladder Co. 1 set up their ladder pipe, but the normal plethora of overhead wires found in many Hudson County neighborhoods hampered deployment of additional aerial devices.

Embers rained down on the entire area to the east; tightly packed blocks of frame dwellings. Union City Police Officers began evacuating all the homes east of the fire. Squad Co. 7 was assigned to ember patrol as well. 30 minutes into the fire, Squad 7 reported that the steeple of Ss. Joseph & Michael Church at 1309 Central Ave. was ablaze! A 4<sup>th</sup> Alarm was transmitted by Deputy Chief Charles Thomas, who was now confronted with fires raging on two fronts!

Founded as St. Joseph's Church, the parish has been serving downtown Union City since the 1860's. In 1981 when the nearby St. Michael's Monastery closed, the two parishes were combined to form Saints Joseph and Michael Church.

The steeple of the church soon became fully involved. Squad 7 set up their Telesqurt but it was difficult to deploy more resources to the church with three buildings roaring and numerous companies and supply lines working one block away! Additional alarms were transmitted, taxing the resources of the 12 communities in Hudson County. Secaucus Tower Ladder 2 was able to make Central Ave. and set up their tower. Eventually North Hudson Tower Ladder 3 was able to set up on 14<sup>th</sup> St. Fire had now dropped down to the main roof and a pitched effort was made to save the church from complete destruction. The steeple, ravaged by fire, would collapse into Central Ave., perhaps sparing the rest of the building from a fiery demise.

With 2 major fires in progress one block apart, mutual aid requests were sent to neighboring counties. Essex County had to decline, as there were 2 fires in progress in Orange and Irvington. Task forces from Bergen and Union Counties moved in to cover vacant North Hudson firehouses.

At 02:45 F. D. N. Y. Box 600 was transmitted, Mutual Aid to New Jersey via Lincoln Tunnel. Eng. Co. 1-14-34 Tower Ladders 12-21, Batt. 7-8 responded directly to the fires. The F. D. N. Y. companies staged on 12<sup>th</sup> St., but did not operate. Last time Box 600 was transmitted was December 1, 2001 when 3 major fires were burning in Hudson County simultaneously.


As the sun rose that cold Saturday morning, the Union City neighborhood was in ruins. Three buildings on Summit Ave. were gutted; the church steeple was a pile of rubble in the middle of Central Ave., the streets, cars and buildings were enveloped in ice and electric power was cut off! Sadly, a one year old boy, an occupant of the original fire building, had perished. His father was

badly burned, but ironically was arrested and charged in connection with the fire about one month later.

The same firefighting group that had the furniture store was on duty that night and the same crew manned Car 26 for both fires! Frozen firefighters were warmed with 4 gallons of coffee, 8 gallons of hot chocolate and 1 gallon of stew. 20 pairs of handwarmers were also distributed.

#### CHANGING OF THE GUARD!

Jersey City Chief of Department Darren Rivers decided to hang up his helmet after a notable career of nearly 35 years. Chief Rivers started his career at Ladder Co. 12 in 1982 and had led the Department since 2010. A ceremony at Fire Headquarters, replete with apparatus, a large American flag and the FDJC Emerald Society Pipes and Drums gave the Chief a fitting send off on his final day, February 28, 2017. A grand celebration was held that evening at the Casino-In-The-Park with nearly 250 guest present.

Carlos, a Life Member of the Gong Club, perished at a 3<sup>rd</sup> Alarm, Box 420, on March 20, 1993. Fireman Lee made the supreme sacrifice on March 30, 1967 at 2<sup>nd</sup> Alarm, Box 57.

The FDJC observed the 24<sup>th</sup> Anniversary of Fire Fighter Negron's passing with a ceremony at the scene of the fire, 411 Palisade Ave. During that event, Gong Club members noted that the 50<sup>th</sup> Anniversary of Fireman Lee's sacrifice was fast approaching so an observance was immediately planned to mark that day. Companies assembled at Holy Name Cemetery off Route 1-9 for a graveside memorial, led by Chief McGill and Department Chaplain, Rev. James Pagnotta. Fireman Lee's daughter and grandson were able to travel in from Pennsylvania to attend the ceremony.

# In The Line of Duty...



Fire Fighter Carlos Negron 1946-1993

There is not a single member of the Gong Club who cannot recall exactly where they were and what they were doing on the morning of March 20, 1993. The most devastating tragedy to strike the Club occurred on a clear, cold Saturday morning at 411 Palisade Ave., Jersey City. Fire Fighter Carlos Negron, the Deputy Chief of the Gong Club, was off duty near his home, picking up a few items at a neighborhood grocery. Cries of "Fire!" rang out and, like any fire fighter or buff, Carlos immediately sprang into action. The fire involved a three story mixed occupancy, a liquor store with apartments above. First Alarm units arrived and began stretching lines and laddering the building to search and ventilate. Carlos, assigned to the Hose and Equipment Shop, assisted his fellow fire fighters without hesitation, helping to search and stretch the first line. Truck Co. 7 was maneuvering a 35-foot ladder on a narrow sidewalk to reach the third floor. Carlos went to assist, but as the ladder was being moved, it brushed near an overhead high voltage line, sending a charge of electricity down the ladder.

Fire Fighter Negron and Fire Fighter Walter Milne were knocked unconscious by the electrical shock. Division 1, Deputy Chief Denis Onieal (who is today the Superintendent of the National Fire Academy), witnessed the incident and transmitted 2<sup>nd</sup> and 3<sup>rd</sup> Alarms plus called instantly for Emergency Medical Services. Both fire fighters were transported to Christ Hospital. Despite the efforts of emergency room personnel, Carlos succumbed to his injuries. Fire Fighter Milne spent nearly sixty days in the St. Barnabas Burn Center in Livingston, NJ. His recovery was miraculous; despite losing a finger and a toe, he remains on active duty today with Rescue Co. 1.

Carlos Negron was a lifelong buff who, for a time, lived next door to the Gong Club quarters in his youth. He joined the Club on January 11, 1973 and would have received a Life Member Plaque at tonight's 50<sup>th</sup> Anniversary Celebration. Carlos was appointed to the Jersey City Fire Department on June 1, 1981 and had worked at Eng. Co. 6, the Fire Prevention Bureau, the Central Office and finally the Hose and Equipment Shop during his thirteen year career. His legacy lives on today; the Gong Club re-named its annual valor Award in his memory in 1993. That same year, Jersey City Fire Fighters and Gong Club members organized the Carlos Negron Memorial Run, which is held annually on the first Sunday of October. Proceeds of the eight 5 kilometer races benefit the St. Barnabas Burn Center. A dedicated buff, fire fighter, father and husband, Carlos Negron will never be forgotten!

#### Greetings from Club Appel 99

*Club Appel 99* had a very busy year in 2016; Canteen #1299 made 54 runs to a variety of calls.

In May and June, one of the traditional activities for members is a fire department tour around Quebec City. This year, many of us paid a visit to Levis and were welcomed by members of the *Club Urgence Rive-Sud*, including the Chief of Operations, Daniel Pageau.

The city of Levis is situated just across the Saint Lawrence River from Quebec City. It has a growing population of 145,000 with six full time fire stations, a Prevention Department and a central Headquarters. In 2015, the Levis Fire Department responded to 2,082 fire calls and 3,202 first responder calls, for a total of 5,284 runs.

One of the main roles of the *Club Urgence Rive-Sud* is to support the Levis Fire Department in staffing its Canteen #1600 on third alarm or special calls and to help Levis firefighters during annual charity events at Christmas, on Blood Donation Day and during other events.

In addition to our visit to Levis, on June 15 of this year, *Club Appel 99* rented a minibus and organized a tour to the Montreal Auxiliary Firefighters' Museum.

Montreal, located at the confluence of the Saint Lawrence and Ottawa Rivers, is about 250 km (155 miles) east of Quebec City. It is situated on the Island of Montreal, with a population of 1,861,900 in 2011. The island is approximately 50 km (30 miles) long and 16 km (10 miles) wide and is the sixth most populous island of the Americas.

The museum shares a heritage building with Montreal Firehouse #30. In 2005, this firehouse celebrated its 100th birthday.
