Discussion on potential upcoming convention sites and dates.

Ottawa, Canada September 12 through 16, 2021 Homewood Suites by Hilton, Downtown Ottawa.

2022 Joint Convention with SPAAMFAA Lynnfield, MA Dates TBD.

2023 Milwaukee, WI Summer 2023.

2024 Richmond, VA September/October 2024.

A discussion took place on the distribution of Anniversary Certificates to clubs marking 25, 50, 75 or 100 years of organization. Executive Vice-President will send them to the Regional VP who will award to respective organizations.

Annual Business Meeting to be conducted via Google Meets on Saturday October 31, 2020.

Meeting adjourned 1:10pm.

By-laws Amendment:

Present: ARTICLE 12 – DUES

Dues in the IFBA shall be set annually by the Executive Board for the following calendar year at the IFBA Spring Board Meeting with invoices being sent out by April 15th.. Dues increases by the IFBA Executive Board cannot be increased by more than 50% of the previous year's dues. Voting on a dues increase by the Executive Board can be done by electronic voting, if necessary.

Proposed:

Dues in the IFBA shall be set annually by the Executive Board for the following <u>fiscal</u> year at the IFBA Spring Board Meeting with invoices being sent out <u>no less than 60 days prior to start of IFBA Fiscal Year (July 1 through June 30)</u>. Dues increase by the IFBA Executive Board cannot be increased by more than 50% of the previous year's dues. Voting on a dues increase by the Executive Board can be done by electronic voting, if necessary.

Elections, per By-laws article herein:

ARTICLE 2 – ELECTION OF OFFICERS

Section 1.

The election of officers for the coming year shall take place at each Annual Meeting. The Chairman shall appoint a Nominating Committee, which shall present a slate of candidates for the Offices of President, Secretary and Treasurer.

Candidates for the Office of Regional Vice President shall be nominated at a prior regularly scheduled and properly announced Regional Meeting at which a quorum of representatives from a majority of the Regions Active Member Groups are present. At such meeting each Active Member Group shall have but one (1) vote. Selection of the candidate shall be by means of a simple majority vote. The names of the candidates thus selected shall be forwarded, at least sixty (60) days prior to the Annual Meeting, to the Executive Vice President who shall cause these names to be presented as part of the slate of candidates for Officers for the coming year.

Nomination of other candidates for any office, other than Regional Vice President, may be made from the floor of the Annual Meeting, provided that:

- 1. The candidate thus nominated has agreed, in writing, to serve if elected, and that,
- 2. The nomination is made, in writing, by a Delegate and seconded, in writing, by two (2) other Delegates, and further that,
- 3. Candidates for the Office of Regional Vice President may not be nominated from the floor of an Annual Meeting.

In the event that no nomination for candidate for the Office of Regional Vice President is forwarded to the Executive Vice President and properly presented at the Annual Meeting, the incoming IFBA Executive Board shall have the power, and responsibility, of appointing a member of one of the Active Member Groups within the Region to serve in the Office of Regional Vice President for the coming year. (Amended 1987, 2019)

Wally Banks moved approval of the Budget with the dues increase. Bob Bowers seconded the motion. The motion carried unanimously.

So, WHAT do we do? Under the direction of the IFBA Chairman (Paul Schaetzle), we look at long-range plans and goals to ensure that the IFBA remains a strong organization. Currently our responsibilities include the following:

- 1. Strategic Planning
- 2. Realignment of Regions
- 3. Viability of a Memorial fund
- 4. Charitable projects
- 5. Review of the Region Vice President Handbook

WHY would the Past Presidents be assigned these tasks? As new members join the IFBA they bring along ideas and information about what they have seen as successful in their own clubs. This is pertinent for the IFBA to continue without becoming stagnant. Those members in time will have years of experience and be able to continue the rich history of our organization. In the meantime, the experience of those on this committee is used to work for the future.

The present members of this committee have a combined total of over 150 years as members of the IFBA, have served on the Executive Board for over 100 (combined) years, and have attended a total (combined) of over 150 conventions. That experience helps us as we provide leadership for the future. Plus, within the committee, the members with more experience within the IFBA mentor those that have less time served.

WHEN do we find time to work on these tasks? Thankfully we now have electronic means like Email, Google shared Drives, Google Meet, phones, and social media that help us connect and complete our work. We are also able to meet in person, during both the Spring and Fall Board meetings (when applicable).

WHERE do we go from here? As we complete our assignments and submit them to the Executive Board for review and discussion, we look to IFBA Chairperson Paul Schaetzle to give instructions as to what else he would like us to work on. On occasion, members of the IFBA bring up topics that need to be looked at and we are then given the responsibility to work on that task.

We encourage all Past Presidents to join us, if not in person, then through electronic platforms and share with us ways we can continue to keep the IFBA a strong organization for years to come.

2020 (October) Report on Congressional Fire Services Institute

This year's CFSI dinner scheduled for April 30, 2020 was postponed until further notice due to the pandemic. Executive Vice President Banks and I attended the National Advisory Committee meeting held on October 2, 2020 through teleconferencing. The meeting included a presentation by Dr. John Howard, National Institute for Occupational Safety and Health, about both the pandemic and the anticipated rollout of the vaccine and the firefighter cancer registry. His slide presentation is attached to my cover email.

Also presented at the meeting were four resolutions covering the following areas: support of a federal initiative to require carbon monoxide alarms in residential properties and places of public accommodation; relaxing restrictions on eligibility for federal disability benefits for catastrophic injuries to firefighters; support for efforts to place firefighters and EMS personnel on the highest priority tier for COVID-19 vaccinations, treatment, testing, and PPE; and support for efforts to provide federal funding for reimbursement to fire and EMS departments for providing treatment in place (rather than only for hospital transports) for low acuity patients. All resolutions were approved by the body.

Finally the meeting included the presentation of the Leadership in Fire Safety Education Award to a representative of the Campus Fire Safety Program and a presentation by the NFPA on upcoming code reviews. This slide presentation is also attached.

Addendum to CFSI Report

There was a virtual meeting on May 1, 2020. There were presentations by Anheuser-Busch about its program to provide cans of drinking water primarily to wildland firefighters and volunteer firefighters and by FirstNet about the new national radio system. Ron Siamicki of the National Fallen Firefighters Foundation was selected as the new Chair of the National Advisory Committee. Three resolutions were presented and approved. They were the following: increased federal support for fire prevention activities, increased support for building and fire prevention departments that enforce building and life safety codes, and support for national, consensus-based building codes that promote fire and life safety while allowing housing choice and affordability.

"HENRY N. WILWERS" FIRE BUFF OF THE YEAR AWARD

The "Fire Buff of the Year" Award, as it was first known, was established in St. Louis in 1967 to honor the man or woman who best exemplifies the qualities that distinguish a Fire Buff's outstanding achievements in the interests of the IFBA and/or the avocation of Fire Buffing. It has been awarded annually since that time. In April 1976 the name of the Award was changed to further honor its first recipient, Henry N. "Hank" Wilwers.

Any Active Member Group or Associate Member may nominate a member of an IFBA Member Group or an Associate Member to receive the honor. Nominations must be made, in writing, <u>to the Executive Office</u>, as described in the attached letter.

There are no specific "qualifications" or "standards" that must be met. The Committee considers (among other attributes): service to the IFBA, service to the local buff club or clubs, service to local fire departments or agencies, service to national fire agencies, assistance to the fire service community in general. The "key word" is, of course, "<u>service</u>". A simple resume, supported by letters of recommendation, is all that is required by the Committee.

If a nominee is not selected, this does not signify a "pink slip" rejection for all time. It simply results from the fact that only one candidate is chosen annually. Should the nominator(s) wish a nominee to be re-considered the next year (or at a later date), a letter to that effect is the only requirement (all files are maintained for a number of years). The Committee does not automatically review these files each year – a re-nomination <u>must</u> be made.

The Committee protects the confidentiality of its deliberations and the identity of the honoree is not made public until the Award Ceremony at the annual convention banquet, nor does the Committee divulge the rationale for its selection, beyond the biographical data presented at the banquet, when all present learn of the accomplishments of the Award winner.

We would like to urge all IFBA Regional Vice Presidents and Member Group officers to make their constituents more aware of this fine opportunity to honor one of their own with this prestigious Award. There are many IFBA'ers who are qualified to join the previous honorees that have been recognized for their achievements.

Norwich Fire was dispatched to 48 Prospect St, In the Greenville Section of Norwich for a reported porch fire with multiple calls. Engine #2 arrived at #57 Prospect St. to find an active fire in the porch area extending up the C -D side walls into the cock loft of the rear section of the apartment house. The crew stretched a hand-line to the C side of the dwelling. Battalion 1, arrived and requested the 2nd alarm to the scene. Truck one arrived and headed to the roof, as Eng 3 and Sq A helped with water supply and interior crews. 2nd Alarm companies supplied additional hydrant lines and man-power. This year has been challenging for those organizations that provide Rehab, support a Museum or both. It can be said that all the organizations have done their very best to adapt, adjust and overcome. While the volume of service has been down and the number of guests limited, all groups continue to provide outstanding service in finest tradition of the IFBA.

The Covid has also limited my participation to 2 visits with the Flying Squad, 3 FFA visits, 1 ODHFS meeting, 1 visit to the 414 Museum, including lunch with the new President, and 2 visits to the Fire Museum of Maryland to observe progress on the SHC display. Buffing has pretty much been limited to Northern Virginia and Baltimore, including escorting visiting buffs.

SHC Guy Cephus is the only surviving member. Mr. Cephus has turned his memorabilia over to the Fire Museum of Maryland. The Museum is working on a display dedicated to the proud heritage of the SHC. Mr. Cephus is recovering from some medical issues and has relocated to a nearby residence to support his convalescence.

ODHFS. The ODHFS has several chapters geographically across the Commonwealth and is the largest group in Region 3 with over 200 members. I attended the Northern Region Meeting in Manassas just before the Covid 19 shut down. As you may suspect many of the ODHFS events were cancelled, but the ODHFS did their best to attended requested "drive-bys" during the Quarantine. Box 234 The 234 Club continues to provide canteen and rehabilitation services to the Baltimore County Fire Department. The club's effort to reach out to volunteers who no longer want to participate in active firefighting but want to stay involved has been quite successful. The county intends to expand Box 234's response area. Box 234 operates 2 units the newest unit being a very impressive rapid response type vehicle. They average about 80 calls per year and dedicate 1200 man-hours to the community.

FFA While the number of runs has been reduced due to Covid the FFA continues to respond with the Canteen Unit to multiple alarms and on Special Calls. The Museum, at 439 New Jersey Ave, NW in the quarters of Engine 3 was on its way to a record setting year until Covid temporarily closed the Museum.

Anne Arundel Alarmers. We have made some progress over the last few months on our new Rehab vehicle. We have taken delivery of a new 2020 Ford F-350 pickup truck. It has a utility body on it and dual wheels in the rear. The County has ordered a new slide-out tray for us, and we can customize the lay-out to fit our purposes. The new unit will carry 2 pop up tents for shade and shelter, 1 large electric misting fan and 3 smaller battery-operated misting fans for the summer. We have cooling towels, and extra water and ice. We will carry a propane heater and walls for the tents, that become warming tents in the winter. We plan to install a 2000-watt inverter for electric power.

Car 1 responds with some snacks and hydrations and can respond immediately from a member home and provide Rehab at one- and two-line fires. Car 1 can also do a quick on scene size up to determine if other resources are needed.

- NEW REHAB UNIT IN SERVICE --

In July, the Alarmers placed in service a new ReHab unit, now designated as ReHab-2. The unit is built on a 2020 Ford F-350 chassis, with a Reading Utility body. ReHab-2 is designed to have a crew of 2 members and be the first unit to respond to emergency calls. The unit has a 3500 watt inverter for AC power, that allows us to make coffee and hot chocolate. For the coming winter season, we carry two 10' X 10' pop-up tents with walls, one on each side of the truck in the high side compartments. During winter months we carry a propane heater to use the tents as warming tents. We carry two 4-person bench seats, 6 chairs, and tarps to define the rehab area. We carry 5 cases each of additional water and Gatorade. We have assorted snacks and chips. During the summer months, the heater is replaced with a misting fan and cooling towels.

Over the past 2 years we have been working with the fire department administration to provide a rehab function that more reflects the standards outlined in NFPA 1584. This new truck allows us to concentrate on hydration, core temperature stabilization, environmental control, and rest. We work with a county Paramedic unit to provide EMS monitoring.








-- TECHNICAL RESCUE at the CHESAPEAKE BAY BRIDGE --

10-3-2020 12:30 Hrs. The Alarmers responded Saturday afternoon, Mutual Aid to assist Queen Anne County Sheriff's Department, Toll Facilities Police, and Anne Arundel County Special Operations units for an incident on the west bound span of the Chesapeake Bay Bridge. A man had climbed to the top of a Bay Bridge suspension tower. A police negotiator and Special Operations members went up in an attempt to talk him down. After about 8 hours, the man was placed in a stokes basket and lowered down about 100 feet, to a point where Kent Island Tower 1 crew was able to reach him, and bring him the rest of the way down to the bridge deck. The top of the suspension tower is about 190 feet above the bridge deck. The bridge deck is about 200 feet above the water. Five lanes of US Route 50 pass over the Chesapeake Bay on parallel spans. The incident had traffic backed up for miles. The Alarmers, using CW-1 and ReHab-2, were on scene for 6 hours, and served 48 hot dogs, some snacks, 2 cases of Gatorade, and 2 cases of water. *Photo credit: Logan Starr Sr*





- GENERALS HWY DWELLING FIRE --

9-25-2020 10:50 Hrs. Box 5-31 Firefighters from Anne Arundel County Fire Department, Annapolis Fire Department and Fort Meade Fire & Rescue Services responded to a 911 call reporting an extensive amount of smoke coming from a dwelling in the 800 block of Generals Highway. There are several homes in the area which are accessed via a private driveway that is approximately one-half mile long. Firefighters arrived within 5 minutes after being dispatched to find heavy fire coming from the basement extending into the first and second floors of a large two story single family home. Firefighters attempted an aggressive interior attack and rescued the resident of the home from the first floor.

Unfortunately, the 77 year old female resident was declared deceased at the scene by paramedics. One firefighter suffered minor burns to his hands and ears and was transported to the Burn Center at Johns Hopkins Bayview Medical Center in Baltimore.

Due to the lack of fire hydrants in the rural area, drop tanks were set up on Generals Hwy, and a 3000 foot relay was established. A Working Fire Dispatch and a Tanker Task Force was requested bringing a total of 45 firefighters and 6 Tankers to the scene.

It took approximately 60 minutes to bring the fire under control. Red Cross was requested to assist two adults and one child who also reside in the home but were not present at the time of the fire. The Alarmers, using CW-2 and ReHab-2 were on scene for over 4 hours, and served 40 hot dogs, some snacks, 3 cases of water, and 2 cases of Gatorade.

Metro Richmond Flying Squad Inc. Richmond Virginia



"Professionally operated by Volunteers"

The Metro Richmond Flying Squad has a purchase contract with the City of Richmond for the former Fire Station 17 at 2901 Bainbridge Street. This process has been ongoing for the past two years and we anticipate taking ownership early in 2021. The building was originally built in 1917 for horse drawn fire equipment and remained an active firehouse until moving to a new facility in 2010.



Plans for renovation of this firehouse include administrative

offices, sleeping quarters and community meeting space. We also plan to incorporate an antique fire department equipment display area and memorabilia throughout the facility.



Currently our organization shares apparatus space at various City firehouses with limited storage areas available. Having our own headquarters will no doubt allow our organization to operate more efficiently and allow our group to grow and flourish.



On October 23rd, 2020, Richmond Engine 21 was dispatched to a trash fire at a scrap metal recycling plant. On arrival heavy fire was reported from a large pile of scrap metal. The pile contained hundreds of scrap appliances, crushed vehicles and even a bulldozer. Fortunately, the large scrap metal pile fire did not threaten any exposures. As Engine 21 began laying supply lines they quickly realized they would require additional help. As additional units were special called, a total of 8 engines, 2 Truck companies,

an air light support unit, 2 Battalion Chiefs, 2 ALS paramedic units, a Logistics supervisor and MRFS Rehab 1 filled out the box.

Crews had some difficulties supplying an adequate water supply to the elevated master streams due to low hydrant pressure. Several thousand feet of large diameter hose was utilized to supply the aerial and master stream devices. The Flying Squad responded with 4 personnel and due to





the large amount of large diameter supply lines laid crews had to physically move the rehab equipment and supplies over 600 feet to the rehab area. Crews began to cycle through our formal rehab area and were medically evaluated while we hydrated, fed, and provided cooling towels and seating under a shade canopy.



From a personal perspective, I had the honor and privilege of being elected as the IFBA Region 3 Vice President. Former Region 3 Vice President, Joe Sullivan, served in this role for 5 years. I would like to thank Joe for his service to the IFBA and our Club personally. Joe has been and will continue to be an invaluable asset to the International Fire Buffs Associates.

Richmond Virginia has also been selected to host the IFBA annual convention in 2024. We look forward to your visit and pledge to host an informative and entertaining convention.



With 2020 coming to a close, let us hope and pray that 2021 will see a return to normal. We are looking forward to the IFBA convention in Toronto and our own muster, tentatively scheduled to be held in June.

With this ongoing pandemic, fire activity remains at near normal levels, even though there were some extraordinary fires to report. The first occurred on November 12 in a 100' x 400' construction company warehouse on Chicago's far southeast side at 118th and Avenue O. The 3-11 alarm fire started around 8:40 p.m. and was declared under control by 11:00 p.m. with a rekindle about 7:00 a.m. the next morning.

On December 10, the CFD fought a 4-11 alarm fire on Chicago's west side at 16th and Kostner. The 100' x 300' warehouse was owned by Best Value Auto Supply and contained more than 100,000 auto parts. A level one Haz-Mat was sounded for this incident. Fire officials also had to deal with low water pressure in the area.

The apparatus that was ordered from Emergency-One has been received over the last few months and put into service. Chicago has received seven new pumpers with 1500 GPM pumps, 500 gallon tanks and a foam bladder. The new engines have been assigned to Engine Cos. 30, 43, 72, 81, 93, 102, and 127. Chicago has also received thirteen new 100' rear mount aerial ladders from Emergency-One that include a new ground ladder complement. The new trucks are replacing 2000-2002 Pierce–Dash rigs and have been assigned to Truck Cos. 2, 3, 4, 17, 22, 29, 30, 35, 40, 47, 49, 52, and 58. Thirteen new Ford Explorers have been received and are currently being assigned. Some of the new Explorers sport a solid red color scheme and others are solid black. Engine 2, the fireboat Wheatley, is back in service from Illinois Marine Towing after undergoing repairs, updates, and a new paint job.

With the retirement of CFD chaplain, Father John McNalis, Cardinal Cupich has appointed Father Gary Graf as the new CFD chaplain. The membership of the 5-11 Club looks forward to working with Father Graf.

With just a few Club meetings in 2020 due to the COVID pandemic, the 5-11 Club membership has decided to cancel the election of officers for the year 2021. All officers will hold their positions until the election of club officers for 2022 that will take place in December. The 5-11 Club canteens have responded to 80 calls for service in 2020 including 45 CFD requested responses, 14 CPD responses, 9 responses for service outside of the City of Chicago and 12 standby/support responses during the periods of civil unrest in the City. Our porta-potty truck is under construction and should be ready for service shortly. The rig was formerly a Triage Unit stationed at Midway Airport. When construction is completed, the rig will enter service with the traditional CFD black over red color scheme and will contain two lighted and heated porta-potty positions inside the rig.

Box 15 Club Inc. - dba Box 15 Fire Rehab Serving Columbus and Central Ohio since 1947

Greetings from Central Ohio! We sincerely hope that all of you are dealing with the pandemic without serious consequences. We're sure that we are not unique, but we've managed (so far) to keep everyone healthy up to this point. We've had a few members exposed and had to quarantine some, but - thankfully - no one has contracted COVID-19. Considering how closely we work with first responders, we've been lucky. In the fire departments that we serve, more than 600 firefighter/Paramedics have been exposed, and several have contracted the virus. Fortunately, all have recovered. The pandemic has caused us to change how we do our day-to-day business. Since March, we've held our monthly business/training meetings virtually, using Google Meets. Early on, we also penned a Pandemic Standard Operating Guideline to address masking, social distancing, sanitizing practices and testing. Most fire stations in the region have been on "lockdown" since mid-March and we've respected that religiously. Since all three of our trucks are housed at Columbus Fire facilities, we only enter the stations as far as our vehicles, maskedup and temperature checked. We stay clear of their living quarters. One "hit" we've taken has been the periodic sales of CFD apparel. We normally hold five sales throughout the year. We cancelled the April, June, August and December events due to the lockdowns. We did not want to bring off duty firefighters or family members in from other stations, which would have potentially caused some "contact tracing" issues. We did get permission to hold an apparel sale at the west entrance of Columbus Fire Station #1 in October. Due to pent-up demand, it was very successful.

We've had lots of other happenings, as well. In April, local radio station **Qfm96** approached us with the idea of providing donated meals to as many first responders as we could. We worked with them and **Raising Cane's Chicken Fingers**, and over a three-day period, were able to provide more than 600 meals to 64 fire stations. **Qfm96** donated most of the funds, **Raising Cane's** provided the food and Box 15 primarily handled the logistics. Using 9 drivers, each route covered two or three fire stations, allowing us to get hot food to each destination in less than a half hour per route. Our relationship with both the radio station and Raising Cane's began in the fourth quarter of 2019 and has been very beneficial to Box 15. We sincerely appreciate the corporate relationships that have been developed over the years. One of those being Thompson Building Associates, a

local fire and water damage restoration contractor. That relationship dates back to 2005, when they provided us with a refrigerator and began providing bottled water. Over the years, they have hosted social gatherings, a football raffle and, most recently, built a GoFundMe page to benefit Box 15. Other corporations including Bridgeway Cummins, Vanner Inc., MSC Supply and Meijer, who all provide ongoing

support to us. You can see more about our Corporate partnerships in the 2020 Annual Report which should be published in late February to early March.

Last April, we revised our Hot Weather Response protocol. Previously, we would go on "standby" with one of our units, beginning at noon on days when the heat index was expected to be 95 degrees or above. Seeing a need, we lowered that to 90 degrees <u>or</u> 85 degrees if "full sun". We would stand down in the evening, after the heat index went below 90. This oftentimes kept us "on station" until 8 PM, or later. With the stations observing restricted access, several times, we would take the truck to a nearby members' house and remain on call from there. During "HWS", we would automatically respond to all working

incidents – fires, gas line ruptures, etc. For 2020, we stood 44 shifts during the hot days and responded to 28 working incidents during those days.

Even though COVID-19 kept us from hosting most of our apparel sale events, it also put a focus on "alternate" funding for us as a non-profit. As such, our donations increased substantially through the year. We just mentioned the GoFundMe page, posted by Thompson Building Associates. In addition, we've received monetary donations from many IAFF Locals and foundations; equipment donations from

Mifflin Fire Dept., Genoa firefighters, Worthington firefighters and Westerville Fire Dept. Back in January, Campbell Restorations presented us with our second "First Wash" decontamination shower. Both Rehab 1 and 2 now carry them. In September, **This Week News**, a local weekly neighborhood publication, ran a nice story about us, which resulted in private donations that approached \$1,000 and we would be remiss if we didn't recognize the Westerville CART team for their ongoing support. We would really struggle if it wasn't for all of these folks.

Even though the pandemic put a crimp in our

meetings and fund-raising efforts, it did nothing to slow down fire activity, and firefighter training continued, as well - although with some modifications to procedures. 2020 was only 20 hours old when we took our first run. It turned out to be a triple fatal, arson fire. Exactly 75 minutes later, run #2 came in and it was a long haul to the northwest corner of Delaware County. For the month, we responded to four second alarm blazes, five working fires, two of them requiring extra companies. To round out the

month, we also provided support for three days of training activities. Box 15 serves a total of 38 fire departments in Franklin, Delaware and portions of Fairfield County and have mutual aid agreements with all the other rehab groups in Fayette, Knox, Licking, Madison, Pickaway and Union Counties. February was a lot quieter, with only two second alarms and one working fire. Likewise, March and April were similarly quiet and May was following the same pattern when, on the 31st, Columbus – just like every other metropolitan area in the country –

experienced multiple days of civil unrest. During that first night, along with a lot of smashed windows,

looting and several relatively minor set fires, someone torched a fourstory, block-long upscale condominium that was under construction. The blaze quickly went to three alarms and companies remained on scene for three days, mopping up hot spots. To date, this has been the largest blaze of the year and the loss was set at 25 million dollars.





Box 15 served nearly 300 bottles of water, 9 pots of coffee, more than a case of Granola bars and 70 breakfast meals, during an 8-hour deployment. Run activity picked up in June with two second alarms, two working fires (one required extra companies) and five days of support for training evolutions. One of the second alarm blazes was an abandoned industrial facility on W. Jenkins Ave., on the south side. The alarm was turned in about 11:30 at night and the structure was fully involved when the first companies pulled up. Only 15 hours later, we had another two-banger. This one was in a two-story apartment

building. It started in an attached garage and spread to three other units. We setup two rehab sectors – on the A and C sides.

During June, we staffed for eleven shifts of Hot Weather Standby, followed by an additional 23 days during July. And July turned out to be one busy month! We responded to seven working fires, two "extra company" fires and a second alarm. We also assisted at a gas line rupture and made sure everyone stayed hydrated, fed and decontaminated during 13 days of training activities. August was nearly as busy with



two second alarm fires, six working fires one rescue run and one gas line rupture. Not as many hot weather standby shifts - only six, and the training support callouts dropped to four. In September, we had only two working fires, but we also participated in the tri-annual disaster drill at John Glenn International Airport. Four more working fires in October,

followed by three additional in November. Normally, we turn out to provide shelter and beverage service tor the annual Columbus Veterans Day parade organizers, but that became a vistim of Covid, as well. This

would have been our eleventh year to work with them. We did respond to a couple of working fires plus an extra company blaze during the month, two were back-to-back events.

December has been unusually quiet (not that anyone's complaining), with only two callouts as of this writing. But one was a record setter. On Wednesday, December 9th, the Central Ohio Strike Team was activated for a

structural collapse at the Killen Power Plant, near Manchester, OH. Box 15 was deployed as well. After an 87 mile trip, Rehab 2 remained on scene for nearly 12 hours, serving enoough food and snacks to keep 50 rescuers happy. We had made plans to change crews, but were advised that we could return, as the Strike Team was going to be released overnight. This was the furthest distance that we have ever traveled for a working incident. December has had only one extra alarm fire , but we've been out several days for training support. All told, 2020 has seen 44 days of training support, 52 fire calls, 2 gas line ruptures, 1 disaster drill and 2 rescue runs.

Lots of other things have been happening, as well, from fire station construction to new apparatus to Command Level personnel changes. Truro Township (Reynoldsburg) finally completed the build of station

#161. The prior station had been a converted general merchandise store. Construction took more than a year, because the original contractor went bankrupt the and replacement contractor had to redo a lot of the original work. Crews

were finally able to move back in at the end of June.

Columbus also added a new fire station - Station #35 is at 711 N. Waggoner Rd., on the far east side of the city. This station had been in the planning stages for more than 10 years, but due to budget constraints, construction was delayed several times. came to fruition in 2020.

The Columbus Division of Fire is also in the process of building a replacement for station 16 in the North Linden area. The original two-bay station was built in the 1950's at E. Weber Rd. & McGuffey Rd. It currently houses an engine company, a medic and a heavy rescue company. Needless to say, it is overcrowded and has been showing its age. The new station is at Oakland Park Ave and Medina Ave. A move of about ½ mile.

There is also a lot of new apparatus in the area. Columbus replaced seven engines; 7 #10,12,17,21,22,26,35 with new Sutphen Monarch engines. All are 1500 GPM, w/750 gal tanks.


Two new Sutphen SPH-100 Platforms were delivered for Station #2 (downtown) and #26 (far west side). Both have 1500 GPM pumps, but no tank water. CFD also placed an order with Pierce for another Ascendent 107' Quint/TDA to replace Ladder #1 (downtown). When delivered in 2021, all TDA's in the city will be Pierce units.

Last year, Mifflin Township (Gahanna) put a Pierce TDA in service and in December 2020, Westerville Fire took

delivery of a Pierce Ascendent 107' to replace ladder #111. It will go in service early in 2021. There has been a lot of other apparatus activity in Central Ohio, including new engines for Genoa Township, Hamilton Township, Jackson Township, Plain and Prairie Townships,



including: Genoa Engine/Rescue 441 (Sutphen), Jackson Twp. Engine/Rescue 203, Plain Twp. replaced Engine 121, Hamilton Twp. Engine 171 (Rosenbauer) and Norwich Engine 80.

Command level movements included several Chief changes Columbus Fire Chief Kevin O'Conner retired at the end of May, 2020.

Assistant Chief Jeffrey Happ has served as fire chief interim during the nationwide process. search Rumor has it that Ex-CFD Assistant Chief and current Fort Worth TX Fire Chief, Jim Davis may be on the "short list". significant Another

appointment at Columbus is the promotion of Tracy Smith to Assistant Chief, to date, the highest rank ever achieved by a female. In February, Chief John Bailot retired and Mark Zambito was promoted to replace him. Madison Township (Franklin County) also have both a new Fire Chief and Assistant Chief. Derek Robinson (previously with Westerville) was hired as Chief, succeeding interim Chief Jeff Fasone.

Then, they filled the vacancy of Assistant Chief, with Chas Adams, who came over from Franklin Township. In July, long-serving Fire Chief John Hoovler (25 years as Chief) retired at Plain Township. Jack Rupp, who had served as Assistant Chief since 2002, was named as his successor. We should also mention that Chief Rupp is the 2020 recipient Marshal's of the Ohio Fire Distinguished Service Award. Assistant Chief Christopher

Menapace retired from Whitehall Fire Dept. and was replaced by K. J. Watts, who was hired away from Lancaster (OH) fire.

Other moves include Greg Eisenacher being named Fire Chief at Grandview Heights, replacing Steve Shaner; Chief Ralph Schillingburg closing out a 33-year career at Hamilton Township. Capt. Wade Edwards

is now interim Fire Chief. Gary Honeycutt retired as Chief at Genoa Township. Asst. Chief Joseph Ponzi was promoted to Fire Chief. Fire Chief Matt Noble retired at Orange Township (Delaware County) and Jeff Warren stepped down from the Fire Chief position at Norwich Township. George Sorge, formerly with Washington Township Fire, was named as a Deputy Chief with Westerville Fire, as was Mindy Gabriel, who came to Westerville from Upper Arlington. Mindy has been named as Westerville Fire's Employee of the Year for 2020.

I think the IFBA must take advantage of our size and aid our associates where needed . i.e. see what assistance the President of the FASCV is requesting in the minutes from the meeting.

In 2021, once there is a vaccination and safe to travel, I will resume my travel plan. My goal is to open communications on the West Coast to promote "Fun, Fellowship & Fire Truck". I also have an eye on a new organization to bring into membership.

Meeting Purpose / Introduction:

- Bob Bowers Explain that we wanted to open communication within the region so we could learn from each other's experience. His plan was visiting each organization but the COVID 19 stopped that plan. Next year's plan is to travel after there is a vaccination available and the coronavirus is under control.
- Steve explain that during his tenure as Regional V.P. for the last four or five years he was not able to get the clubs in region 7 together for a meeting or a call.
- Bob express that he believes that opening communications between clubs we can share our experiences and learn from each other. As well as utilizing the size of the IFBA.

I.F.B.A. Report:

 Wally Banks, Executive Vice President gave a report on the cancelation of the Nashville convention and reported that Next year's convention is in Ottawa. He also expressed that the IFBA is there to help organization when needed and to spreed that word of "Fun, Fellowship and Fire Trucks".

Old Business:

• Club / Organization Reports

Bruce Dembecki reported the FASCV is in good order. Their canteen service has 3 trucks. Including a Dodge pickup truck that transports food and drinks to incidents. They are funded by payroll deduction and their membership dues of 65.00 per year. Their budget is \$12,000 per year. Which pays for the snack type of food and drinks. If they serve meals, they are paid for by the department.

Today's Roster contains 37 members. Of these, 2 are Limited members (under 21 years of age and not eligible to drive), and 7 are Associate Members (former members who have left the area but retain contact). Of these there are currently 16 members involved at some level in incident response, and 4 additional prospects going through the membership process. - we have added 5 new members this year, while we have sadly lost 3. The 5 new members are active in incident response, those we lost were largely inactive. With 4 prospective members in process, we will probably end up with 9 new members this year. So, a strong net gain. As a source of new members, we have been getting members through Trade Schools.

Operations during COVID 19 continued uninterrupted. We did however write new operating guidelines, changing some aspects of our service in the field - adding mask and glove use at all times in the field, removing some items from our menu (we no longer serve food from communal boxes - nothing people have to put a hand in and pick an item - with donuts being

the most obvious example, but another good example is pizza, hands in a box exposed to all the food is no longer permitted), we serve only individually wrapped food items. We also changed the way we serve bottled water and Gatorade - with our members being positioned between crews and the coolers, only our gloved hands go into the coolers, no first responders' hands. There were other minor adjustments to our field protocols because of the COVID crisis. In March we wrote up a document outlining the changes in our field operations and shared it with the Chiefs of our 11 fire departments, advising them of systems for managing COVID risk, we know this document was shared down the line. This document received high praise from the Departments.

2019 saw us hit a new high, with 106 runs. That 106 number includes 20 PR events - Parades, Pancake Breakfast and so on, and a large-scale drill. (So, 85 emergency responses)

2020 to date has us at 92 responses, with COVID cancelling all PR events and multi-unit drills. November and December are usually slower months, we may not make 100, but we will be close.

The largest difference between the 85 responses in 2019 and the 92 YTD for 2020 revolve around 10 responses made to support Fire and Police during major civil unrest in May and June.

Additional restrictions on Fire Station access made for limited to access to one of our Fire Support Units. We choose to work around that by using the other units, keeping FSU1 out of service. We were able to negotiate a return to access this month and FSU1 is back in service. Had we needed it we would have found a way to get it, but we were happy with it being safely tucked away in the fire station.

An additional impact of the COVID crisis was on our monthly meetings. Our March meeting was cancelled the day of when the County closed Fire Stations to outside visitors. In April we also did not hold a meeting. By the time of our May meeting it was apparent this would not be resolved quickly so we switched to a virtual meeting format. Since May we have successfully held our monthly meetings via Zoom, with a higher than normal attendance rate.

Steve Fickenscher reported that the Seattle Fire Buff Society has 20 members after adding 2 new member this year. As in any organization there are about 10 active members. For 2019, we did 138 runs. For 2020, YTD is 141. We did not have to stop the canteen unit at any time during COVID-19. For our responses during COVID, the only difference was that we needed to follow the COVID-19 safety protocols established by the department. Other than that, it is business as usual for the responses. The only impact we have had for COVID-19 is that we are not allowed to have our meetings at the fire stations. They are planning of getting a new canteen soon to replace their 1984 Ford Van.

Bob Bowers reported that the Hall of Flame Volunteer Organization has had a change of Management at the Executive Manager's position. He has new and different ideas in directing utilizing the volunteers. We had the Captain and Sargent of Arm resign from our organization.

The remaining officers rewrote the Bylaws and had a couple of meetings with the owner of the museum. After a rewrite of the Bylaws, we have come to an agreed on how to move forward. The biggest issue is management understanding that volunteers not employees and how to best utilize them, mixed with staff to accomplish the goals of the museum.

We have had an increase in membership in the last month by six new members. Total membership in now 46.

New Business:

 - Steve made a motion to elect Bob Bowers Region 7 V.P. seconded by Bruce. The motion carried unanimously

- October 31, 2020 by IFBA Business Meting by google Group
 Live video feed & Phone
- Brue brought up some issues he needed resolved and asked for help from the IFBA to assist.

Bruce asked for help in becoming a 501(c) organization. They have been rejected two of three times; they are being recognized a fire department, which they are not.

My requests can the IFBA negotiate with a commercial organization to provide such services to all member clubs. While we may only need a background check 2 or 3 times a year, and our needs are probably similar to our sister organizations, the IFBA acting on behalf of all clubs would represent a much larger volume to a commercial vendor.

Of course, we realize there will be a fee for such services from a commercial vendor, we expect to include such amounts in application fees.

Also by adopting universal background policies this could lead the way to some form of reciprocal membership arrangements being setup with IFBA member groups - If a member of Fire Associates picked up and relocated to Richmond Virginia there could be some simplified process for such a person joining the Flying Squad, for example.

Can IFBA negotiate with a number of vendors for things many of us need - uniforms, badges, Hero Wipes, rehab supplies (I could use new misting fans for all my rigs, be nice if a vendor gave us a good deal) and so on...Just thinking out loud. Also... what resources can we share. Fire Associates is buying an ID Card Printer this week -Once it arrives if anyone else wants us to print plastic id cards, we would be happy to do that for a small contribution to cover supplies.

- Bob Bowers asked Brue to send all of us a copy of their Bylaws so we could review and make recommdations.
- Wally asked him to email his other request out so he could see what could be done within the IFBA to assist his organization.

Conclusion:

• Bob thanked everyone that was on the call and hoped that their time invested was worthwhile. Bruce thought the call was good and looked forward to the next call.

IFBA Region 9 Report Annual Meeting October 17, 2020

I am pleased to submit this report on the activities of Region #9.

As has been previously reported, the 4 New Jersey Canteen Clubs—Box 54, Teaneck; Gong Club, Jersey City; Bayonne Fire Canteen; and The Bell & Siren Club, Newark-- were fortunate to be the beneficiaries of a UASI grant, administered through the Bergen County OEM. All the members of these Clubs received yellow reflective work jackets with cold weather liners, pop-up tents; portable generators; portable light stanchion; and Cambro urns. Besides this, the Clubs used their share of the funds to buy items specific to their needs, including outfitting members with Unication Digital pagers & outdoor heavy duty heaters.

During the height of the Corona virus earlier this year, Box 54 and the Bell and Siren Club took themselves out of service for several months. Both Clubs have limited membership, and a significant percentage are in the "high risk" category. The other NJ Clubs as well as the Philadelphia Second Alarmers continued their service. By July all Clubs were back in service.

Fire Bell Club of NY

Nothing new is really happening. Meetings are conducted via ZOOM. The Fire Commissioner has given approval for them to meet in person if their quarters are large enough to support social distance guidelines. Unfortunately theirs is not, so they will have to look for another location before they can again have in person meetings.

Philadelphia Second Alarmers

Because of a significant decrease in multiple alarms, the Club decided several years ago to respond to "All-Hands" working fires. In 2019 there were only 19 multiples but the Club responded over 700 times, and so far in 2020 there have been 7 multiples, but total runs are almost 600!

They are fortunate that they have the manpower to support this workload, including having at least one member at their station 24/7. This allows for a rapid response to the workers, with other members meeting the truck at the scene. Their major source of recruitment is using Facebook, Twitter, & other social media. Currently they have 24,000 followers on Facebook.

With the increased responses, they felt the need to add to their service menu and since they are at all workers, PFD is utilizing the Second Alarms to provide:

- 1. Replacement batteries for FD radios
- 2. Replacement helmet hoods
- 3. Hand Warmers
- 4. Decon wipes of various sizes
- 5. Spare SCBA air tanks which they swap out for empty ones

The Second Alarmers might be the oldest Club in the IFBA, having been organized in 1921. Plans are under way for a 100th Anniversary celebration on Saturday Oct 9, 2021 which will include an open house of their expanded quarters, as well as a possible banquet. Save the date!

Gong Club

While continuing to serve at fires, the pandemic caused the club to cancel the annual Negron Run, the FDJC Family Picnic and plans to celebrate their 70th Anniversary. The new date for the 70th dinner is November 20, 2021.

To date the Club has responded to 35 incidents.

The major issue hanging over their heads is the status of their quarters. The area were the Club is located is undergoing gentrification and Jersey City wants to sell their building. The Club has not heard anything definite, but it looks like after all these years the "House of Gong" will have to relocate

Bell & Siren Club

Continuing the trend of the other Clubs, runs are also down, with only 25 responses year to date. The Club did miss several runs when they were out of service due to COVID concerns, but in past years at this time, about 50 runs would have been logged.

They also decided to cancel their Annual December Holiday Party. This event was always very popular not just with the members but also with the Chiefs and firefighters of the towns Headquarters #17 serves.

Bayonne Fire Canteen

They continued service through the worst months of the pandemic.

Box 54 Club

They are unique among Region #9 Clubs in that their 3 trucks are owned by the Teaneck Fire Dep't., and they get a lot of their supplies through the FD. The downside to this is that Box 54 is beholdent to the city for funds for a new canteen, which they desperately need. It is no surprise that this request is one of the first to be cut from the municipal budget. If they were to try to organize their own canteen fund drive it could result in the town totally severing its relationship with the Club, taking back the trucks, ending some supply funding, etc. Along with the need for members, the replacement of their current canteen remain the Clubs biggest challenges.

At our virtual Region #9 meeting held in the Spring, it was a privilege to be nominated to serve another term as Vice President. I would like to thank all the Region #9 Clubs for their support, as well as that from the entire IFBA leadership and Executive Board team.

As 2020 draws to a close we are all hopeful that 2021 will be a better year, and with the new COVID vaccines we can return to some sense of normalcy.

Fortunately none of our members or their family passed away from the virus. Since many of our active members are "seniors" & in the high risk category, the Club reluctantly decided not to respond to fires during the height of the virus in the spring. From April-June, our Rig, Headquarters #17 was out of service and we missed 7 multiple alarms.

Prior to resuming our responses in July, we established several protocols, including:

- a. No more than two members on the Rig
- b. Temperatures of members to be taken & recorded on our Rig report
- c. Gloves and masks to be worn at all times
- d. No self-service for the firefighters. All drinks & food to be handed out from the Rig
- e. Rig to be cleaned and sanitized upon return

We are pleased that during the time we were out service the firefighters were understanding and we did not receive any complaints.

Unlike many places, Newark and its surrounding communities were spared the riots, burning and looting that occurred during the summer in so many of America's cities. While there were street demonstrations and marches, for the most part they were peaceful resulting in few arrests and no significant arson.

One positive note of the past year is that the UASI grant for the 4 IFBA canteen clubs in Northern New Jersey was finalized. Early in 2019 the Bergen County (NJ) Office of Emergency Management contacted the clubs about participating in an Urban Area Security Initiative (UASI) Grant Program. The clubs were: Teaneck Box 54; Bayonne Fire Canteen; Jersey City Gong Club; and the Bell & Siren Club.

Region #9 VP Ira Cohen coordinated efforts with Bergen County OEM D/C Matthew Ziemkiewicz and each club submitted a "wish list" of equipment they could use. After much discussion, the clubs each received:

- a. High Visibility Reflective work jackets, with winter liners, for all members
- b. One Honda portable generator
- c. One large pop-up tent with side walls
- d. Two misting fans
- e. Cambro thermos jugs
- f. Portable floodlights
- g. Outdoor Heaters
- h. Unication G5 voice pagers for all Box 54, Bayonne Fire Canteen & the Bell and Siren Club members

It took some time, but several months ago, all items were finally received by the clubs. We are especially happy to have the pagers as Newark switched frequencies to the trunked P25 NJ State System, and this allows all our members to not only monitor Newark's transmissions, but also to have it for the tone alerts for Headquarters #17. Moreover the pagers are programmed so we can monitor many of the surrounding towns that are also on the P25 system, as well as those on the old analog UHF bands.

Normally, Headquarters #17 responds to about 75 runs a year. For whatever reason, multiples in Newark and the surrounding towns were way down in 2020. As the year draws to a close, we will finish with only about 30 runs.

One of the COVID casualties was the cancellation of our annual December Holiday Party. This was the first time in our 71 year history that the Bell & Siren Club did not host a party. Not only are club members and their spouses invited, but we also extend the invitation to the Chiefs & Union heads of the departments we serve; members of the IFBA Executive Board; and representatives of other Region #9 buff clubs. Hopefully the festivities can resume next year.

FIRST A HEAT WAVE...

A generally accepted definition of a heat wave is "a spell of three or more days on each of which the maximum shade temperature reaches or exceeds 90°F". Jersey City's 2nd Battalion could amend that definition to include three or more multiple alarms with the temperature at or above 90°F!

Tuesday, July 28, 2020 saw a thermometer reading of 88°F at High Noon, which crept up to 91°F by late afternoon. Summer road work was in full swing with a number of streets in Jersey City's west side closed for repairs. An excavation by a gas crew prompted a number of calls for a gas odor at Harrison Ave. & Kennedy Blvd. and other locations. An automatic alarm at 137 Monticello Ave. added to cacophony of mid-day traffic.

At the height of all this activity, the Fire Dispatch Center began receiving calls for a building fire at 246 Virginia Ave., a large 3 story mixed use occupancy at the northeast corner of West Side Ave. Box 759 was transmitted at 12:28 with an odd assignment; most of the 1st Alarm companies were tied up at the other incidents in the area. First due Eng. Co. 17 had just cleared from Monticello Ave. and responded. Capt. Joseph Dagato reported "smoke showing from the top floor; stretching a line". As the Working Fire assignment was being dispatched, Fire Dispatch advised Batt. 2 of reports of an elderly woman in Apt. 7. Batt. 2, Batt. Chief Sean O'Connor, assigned the Field Training Officer, Batt. Chief Glenn Youncofski, to interior operations.

Batt. Chief Youncofski reported water on the fire and a primary search of Apt. 7 was underway. Batt. 2A reported the bulkhead was open and he was doing a 360° from the roof. Not liking the conditions observed, Batt. Chief O'Connor transmitted a 2nd Alarm at 12:40 as Deputy Chief Joseph Menendez arrived and assumed command. 2nd Alarm companies were ordered to stage on West Side Ave. and report to the command post.

As the search of Apt. 7 proceeded, fire suddenly roared out of an interior shaft, rolling across the top floor ceiling. Capt. Julio Ortiz, Eng. Co. 19, was now cut off from the interior stairs. Batt. Chief Youncofski, seeing this predicament, transmitted a Mayday! Lad. Co. 6, the FAST truck on the Working Fire assignment, sprang into action. Deputy Chief Menendez transmitted a 3rd Alarm. Res. Co. 1 Roof now reported heavy black smoke from the bulkhead. A ground ladder was hastily raised to the 3rd floor front corner window and Capt. Ortiz scampered down the ladder; problem solved! An accountability roll call was then conducted.

Persistent reports from an occupant of another person still in the building prompted Car 3, Chief of Dept. Steven McGill, to order another primary and secondary search of the entire structure. Both proved negative. Fire was declared under control at 13:10.

Car 26 responded on the 2nd Alarm, fighting heavy traffic across town. Upon arrival the crew of two deployed the misting fan, 3 wheeled coolers and distributed 70 cold towels in addition to operating from the rig. Heat stressed fire fighters downed some 7 gallons of Gatorade and 216 bottles of water.

Response:

Less than 6 hours later, Battalion 2 companies were back at it again, this time a scant 2 blocks from the 2nd Battalion quarters. Numerous calls were received for a fire across the street from a nursing home at 198 Stevens Ave. Box 877 was transmitted at 18:17 hours. Batt. 2, Batt. Chief O'Connor arrived first, confronted with heavy fire in the rear of two 2 story dwellings at 197 and 199 Stevens Ave. Batt. Chief O'Connor transmitted a 2nd Alarm upon arrival.

Companies found that a car was alight in the rear yard of 197 Stevens Ave. with the siding and interior of both buildings now involved. Fire fighters swarmed into both buildings, quickly knocking down the interior fire. Access from the rear was challenging; the "street" to the rear, High View Rd., is a narrow, twisting path with 2 90° turns. But, quick work by the battleweary companies turned the tide! Fire was confined to the two buildings and the vehicle.

The same crew staffed Car 26 for this run, serving thirsty troops another 5 gallons of Gatorade and 138 bottles of water.

Wednesday's heat was even worse; the July 29, 2020 high for the day was 93°F. Jersey City Group D fire fighters had a relatively routine day. Night time didn't bring much relief. The temperature was a balmy 80°F at 02:52 when Box 834 was transmitted for a fire at 1716 Kennedy Blvd. This address sits at the northeast corner of Linden Ave. & Kennedy Blvd., a block and a half from Eng, Co. 13's quarters. The building is an oversized brick apartment building on a double lot. The ground floor houses a popular eatery, Vincent's Pizzeria.

Eng Co. 13 arrived quickly with Capt, John Yanick reporting "3 story Class 3 mixed occupancy; heavy smoke showing throughout the building. We're lining in!". Battalion 2, Batt. Chief Peter Griese, was right behind Eng. 13 and reported "Heavy smoke from a pizzeria. Lad. 8 take the front of the building; Ladder Tower 4 take Linden Ave." A mere 2 minutes later, Batt. Chief Griese was back on the radio, "Batt. 2, STRIKE a 2nd Alarm!" He followed with a brief progress report, "One line in operation; stretching a line to the floor above; searches underway".

Deputy Chief Richard Casella took command at 03:08, reporting fire in a corner building, 3 story, Class 3, mixed use; heavy smoke throughout. Fire started in the basement and has spread. Ventilation is underway; all companies engaged. Batt. 2 reported extension to the stairway between the 1st & 2nd floors; fire being knocked down; checking for extension.

Eng. Co. 22, Capt. James Farrell, reported they were "in the basement knocking down a large amount of fire. The majority of the fire was in the basement; making progress". Meanwhile Squad 4 reported fire in the walls on the 2nd floor. Deputy Chief Casella special called another battalion chief; Batt. 1 was assigned.

Batt. 2 reported extension to the left and right apartments, while Res. 1 roof team called for a thermal imaging camera on the roof. There was too much going on here; fire was extending up in several areas. Deputy Chief Casella, at 03:27, radioed "Give me a 3rd Alarm here. Have the 3rd Alarm companies stage at Danforth Ave. & The Boulevard and at Greenville Ave. & The Boulevard". At 03:41 Deputy Chief Casella reported "Majority of the fire has been knocked down. Companies are engaged in extensive overhauling; checking for extension. Primary search is complete; secondary search starting. Awaiting arrival of the 3rd Alarm companies. Have Car 26 open up". Eng. 17 then reported that the stairs from the 1st floor to the basement were gone; burned away and they were putting caution tape up. Batt. 2 reported the only access to the basement was from the Bilco doors.

All hands worked for nearly another hour before the fire was under control and companies could start taking up. This fire marked the end of a 32-year career for Batt. Chief John Bowen, Batt. 3. His retirement would take effect at 08:00. For his final tour, his son, Probationary Fire Fighter Jordan Bowen, was assigned to Batt. 3. After the fire was under control, Deputy Chief Casella thanked Chief Bowen for his service over the air. All hands gathered in the middle of the street and gave Batt. Chief Bowen a standing ovation!

Three members operated Car 26, including Club Secretary Bobby Scollan who walked from his home 5 blocks south of the fire. 10 gallons of Gatorade and 160 bottles of water were served. The misting fan was deployed and 50 cold towels distributed to provide some relief from the heat.

THEN A TROPICAL STORM!

Less than a week later, Tropical Storm Isaias came roaring into the area. Although Hurricane Sandy was 8 years ago, any warnings of tropical storms or hurricanes send New Jersey residents expecting the worst! The storm made landfall in North Carolina as a Category 1 hurricane but by the time it reached New Jersey on August 4, 2020, the system had been downgraded to a tropical storm. High winds and rain battered the state for the better part of the day, resulting in 2 fatalities and nearly 1,500,000 customers were without power for a portion of the day.

A crew manned Car 26 for the day, but no fires thankfully occurred at the height of the storm. Plenty of downed power lines and trees kept companies throughout Hudson County extremely busy. The storm, however, was short-lived; by 18:00 hours the sun was shining! As the weather turned for the better, North Hudson Fire Control began receiving calls for a building fire at 811 12th St., Union City.

Companies arrived to find heavy fire in the rear of a 3-story frame dwelling on a short block between Summit Ave. and Kennedy Blvd. Fire was extending to a similar detached exposure. 2nd and 3rd Alarms quickly followed and Car 26 was out the door quickly.

The units on the greater alarms swarmed over both buildings and knocked down the fire in short order. Extensive overhauling in both buildings kept the full 3rd Alarm assignment working for some time. The 4 members working Car 26 kept firefighters hydrated with 5 gallons of Gatorade and 120 bottles of water.

APPARATUS UPGRADES

Other than a fatal 3rd Alarm in a senior citizen high rise at 92 Danforth Ave., Jersey City, on October 16th, fire activity throughout Hudson County has been unusually quiet. This calm gives us an opportunity to recap apparatus improvements in Jersey City and North Hudson.

Pierce delivered 3 XT Model 2000 GPM pumpers, assigned to Engine Companies 5, 11 and 22. Department Chaplain blessed the new rigs at Fire Headquarters on the swelteringly hot afternoon of July 6, 2020. Ten of Jersey City's engine fleet are Pierce products, including Squad Co.4. Their 2007 American LaFrance has been retired. A 2003 Pierce that previously saw duty at Engines 9 and 22 has been re-lettered and assigned permanently to the squad. A new rig is slated for them in the coming year.

Also retired was Ladder Co. 4's 2003 American LaFrance 75' tower. A 2020 Pierce 95' tower is now responding from the 1894 firehouse that they share with Eng. Co. 22. This is Jersey City's 2nd Pierce 95footer; a 2014 model is assigned to Ladder Co. 6 Downtown.

At 8:33 P M. the Jersey City Fire Alarm office began to receive a series of 'phone calls and boxes for a fire at 116 Ogden Ave; Box 424 was struck at Palisade and Boorean Avenues. First arriving companies found a building at 116 Ogden Avenue heavily involved, with exposures close on either side. The Fire Ticket reads as follows: 8:35 P. M. Box 424 Fire reported at 116 Ogden Avenue. Companies responding, Engine 7 and 14, Truck 3, Rescue 1, Battalion 3 (Ch. Ruoff) and Division 1 (Ch. Cardillo) (ED. NOTE) Engine 18, normally assigned on this Box was relocated in the quarters of Engine 20. This was because of the large brush fires in the Caven Point area. Engine 14 responded to fill a reduced assignment. 8:36 P. M. Engine 7 reports a building fully involved; the assignment is filled out by the dispatchers. Companies responding: Engine 5 and Truck 6 (both are due on the second alarm). 8:37 P.M. 2-2 B/O Battalion 3 fire at 116 Ogden Avenue. Companies respond-ing and their normal response: Engines 6, 15, 17 and Truck 9 (all assigned on the third alarm) and Rescue 2 (second alarm). 8:41 P. M. 3-3 B/O Division 1 - Heavy life hazard with people missing in the building. Ambulances needed for civilians being removed from building. Companies responding: Engines 4 (second alarm) 18 as 20 (relocated) AND I (not assigned on the card) Truck 2 (not assigned on the card) Battalion Chiefs of the first and fourth were special called to bring Scott bottles for a search of the fire building due to heavy smoke and fire. 9:45 P. M. HQTRS. The following relocations completed: HOBOKEN--Engine 1 to J. C. Engine 4 Engine 3 to J. C. Engine 5 Truck 2 to J. C. Truck 6 BAYONNE--Engine 3 to J. C. Engine 19 Engine 5 to J. C. Engine 19 Truck 3 to J. C. Truck 8 UNION CITY--Engine 1 to J. C Engine 18 Engine 4 to J. C. Engine 18 Truck 1 to J. C. Truck 3 JERSEY CITY--Engine 9 to Engine 11 Truck 4 to Truck 9 9:53 P. M. Recall. B/O Chief of Department Raymond A Gibney, 25 men from group (C) to be called back to duty with their respective companies. Editor's Note: During this time the companies at the scene were engaged in searching the buildings for survivors. Six persons were rescued at the scene during this time but two of these lost their lives in the fire. Spectacular ladder work and truck work kept the death toll from reaching any higher. 1:16 A.M. RETURN. Return Signal sounded B/O of Chief Gibney, indicating the fire extinguished and companies being returned to service. 1:30 A.M. Gong Club Canteen returned to quarters.



PHILADELPHIA RESPONSE TEAM EMBARKS ON IT'S 100th ANNIVERSARY

Arriving at the 2900 block of Roberts Avenue in East Falls, you may think you're at a Philadelphia Fire Department station. Red trim around two bay doors that open up to reveal four large, red and white response vehicles with gold lettering. Equipment on the vehicles all stained with the smell of smoke from past fires. These are not Philadelphia Fire Department vehicles, however, and those inside the building are not on-duty Philadelphia Firefighters.

They are on-duty though.

The all-volunteer Second Alarmers Association of Philadelphia is ready at a minute's notice, keeping watch 24 hours a day, seven days a week on Roberts Avenue for any emergency that may call upon their service. Their service is needed when first-responder operations are prolonged at city events and emergencies, where health and safety of Philadelphia Police and Philadelphia Fire is of concern. Their mission statement is "to provide rest and rehab to the Philadelphia Fire & Police Department", but their actions go beyond that.

Past and Present

The Second Alarmers were born out of an emergency. In 1921, a large fire on the waterfront kept police and fire working long hours on a chilly February night. A group of residents, noticing the effect of the weather on first-responders, jumped in their cars, bought coffee, and returned to the scene. It was this "sense of taking care of those who take care of the public" that created the group. That has remained its core value almost 100 years later.

Having begun as a Canteen Unit and primarily providing food and drink for police and fire, the association has become more intrinsic and inter-woven in emergency response beyond coffee. From the derailment of Amtrak 188, Hurricane Sandy, Pope Francis' visit, and a seven-alarm fire this past August. The Second Alarmers cover over 700 responses a year. In 99 years of service, the Alarmers have made nearly 15,000 "runs" and with the year 2020 ended with 742 runs in just one years' time and has broken all previous records. They now assist with replacing first-responders' clothing, radio batteries, and oxygen-filled breathing cylinders.

Leadership

The man in charge of the Second Alarmers wears two hats, and two titles, literally. At 2900 Roberts Avenue, Gregory Masi is known as Chief, in charge of the all-volunteer organization. However, Philadelphia Police call him Sergeant, as Masi has been with the police department for decades and has since retired from their Communications Division.

Mr. Masi, who has been with the Second Alarmers for two decades, volunteers about 20-30 hours per week into the Second Alarmers. It's a family affair as his wife Marsha volunteers with him, providing "creature comforts" as Masi calls it. "This is my greatest hobby and it's a chance to give back to first responders, to show them the public appreciates what they do", says Masi.

Why Volunteer?

When parents are working long hours and people have multiple jobs, finding extra time during the week to volunteer is at a premium.

It's a sense of service and giving that brought Nicholas Keck to the Second Alarmers years ago. By day, Keck delivers medical supplies to people in need. At the Second Alarmers, he serves as Assistant Chief. Having two young children at home it makes it tough and the running-around constant. But Keck believes he's helping to make a difference.

Mr. Keck responded to the Amtrak 188 derailment in May of 2015. He found himself and his volunteer group called into action.

Keck explained, "The train derailment that night, police and fire were just really grateful towards us. We were able to provide wide lighting to help people get around safely. We had portable generators for the light towers. We took them off our trucks and brought the lighting to the scene. They were just ecstatic that we were able to help them with that so much." The association is also proud to have its first female officer that being a Lieutenant. As Amanda Specos-Perkins been near active 10 years she has actually been involved with the association most of her 30 years as her father Peter Specos is a Life Member who has been with the association for 35 years as well is now currently serving as a Lieutenant and is also a Paramedic with the P.F.D.



How You Can Help?

Chief Masi calls the Second Alarmers "Philadelphia's best kept secret". On October 9th 2021 the association will be having their 100TH celebration at their station with plenty of activities planned. It is also the weekend prior to the INTERSCHUTZ USA CONVENTION that will be held at the downtown Convention Center October 13th-16th 2021.

"Citizens automatically assume that we are part of Philly Fire, when in reality, we are 100% volunteer", says Masi.

The organization is comprised of near 50 volunteers. Over the years, the Second Alarmers have expanded in diversity and have people from all walks of life involved, from an architect to other first responders – something that Masi likes and wants more of.

The Second Alarmers are always looking for more volunteers and appreciate those who bring various skills sets and varied background to the organization.

Report from the Greater Toronto Multiple Alarm Association, Region 10

And that was the year that wasn't, at least with the Greater Toronto Multiple Alarm Association. When the Pandemic restrictions began in March, the two rehab services in Toronto were put on hiatus and have remained so all year. In person meetings were suspended and our monthly gathering has been virtual ever since. Our sister organisation, the Ontario Fire Buffs Associates, also had to suspend photo tours and cancel the annual meeting, events attended by our members, especially the show and sale. In addition, the Annual Firefighter's Toy Drive, which many hours contributed by our membership, was highly restricted this time out. We hope with the new vaccines and the major lockdown underway here that we can keep the infection rate down to manageable levels and resume out activities.

While we may be quiet, Toronto and area emergency services have not. With many people home all the time, and often experimenting with cooking, dwelling fires are up significantly from last year. Most of the professional activities that seem to result in fires are not restricted so vehicle work, construction and home repair such as plumbing and roofing have continued. Dwelling fires have increased while commercial and industrial fires are down as more people work from home and factories and stores close. Major fires were well down from the hectic pace of last year (14 3rd alarms, 5 fourths, 5 fifths) but December turned very busy with a 3rd, a 4th and two 5th alarms bringing the unofficial to 13 3rds, 3 4ths and 3 5ths. Here is a look at some of the major outbreaks:

On June 4, a row of 2-story brick Victorian houses downtown was being renovated into a condo project and being repaired after the east end units were destroyed in a four alarm fire in April of 2019. Multiple callers reported heavy black smoke from a middle unit and comms added the squad, knowing this was a major outbreak. P.325 had heavy smoke from all floors at the front in 473 and 475, P.333 got to the rear to find heavy fire conditions and big lines were pulled while A.324 (east) and A.312 (west) set up at each end of the alley that runs behind these buildings, and AT.333 was erected in front. Meanwhile, with flames rolling 20' above the buildings and the blaze extending through 471 and threatening 469, these premises were quickly searched and P.315, P.332 and HR.332 endeavoured to cut off the fire. Once the heavy elevated streams were applied, especially from AT.333, the inferno darkened down and the crews were faced with a knock-down drag-out fight with unstable structures (most of the fire building was now collapsed) and hidden pockets of fire throughout the old dwellings. Ground ladders were used to access the back portions, including the 2-story extensions typical of these houses. A collapse zone was set up in front and the tower used to get at areas needing attention. Lots of saws, axes, pike poles and even a water lance were employed in extinguishing what was left. Most of 473 fell in, along with portions of 475, and 471 was heavily damaged but it took just over an hour to achieve knock down.

A fourth alarm at 473 Queen Street East on Tuesday, June 2nd.

F20087587 - Visible from a long way off, flame and black smoke boiled from the roof of this large, single-story concrete block industrial mall as east-end companies responded to the Armadale neighbourhood. P211 stretched in while A213 set up their ladder pipe. More lines went inside and to the roof but parked vehicles prevented a second ladder pipe being set up. Almost half the roof was burned but extension inside was minimised. The building was being worked on at the time, damage is \$500,000.

On September 24, a fourth alarm in the north-west corner of the city. Flames spread rapidly through vehicles inside this large auto repair and storage facility, involving much of the inside and breaking through the roof as TFS crews arrived. Interior crews tackled the inferno as A411 set up at the D side to provide a master stream. There were around 60 cars inside and the intensity of the blaze soon forced an exterior attack. A142 went in service from the front and AT114 was placed at the rear but the water supply was insufficient to use the tower. At least six lines were deployed in the 90 minute battle, much of the roof collapsed but the front area was saved with losses around \$5 million, overhaul took several hours.

A fourth alarm at 5 Kenhar Drive on Thursday, September 24th.

F20095293 - December was quite busy with the first large fire coming on the 5th, again in the northwest on Frederick Tisdale Blvd. This time flames were tearing through a 3-story townhouse complex being constructed in a difficult to reach community. An interior attack soon became untenable as parts of the building began to collapse. Master streams were quickly brought to bear but it was a challenge to get sufficient water from the residential mains. With two ladder pipes and ground monitors along with several hand lines in use, a five-pumper relay was set up from the 12" supply on the main street several blocks west. A Bronto was added to the arsenal and the blaze was contained to the original six-unit structure.

After that, on December 10, a hoarding situation in an apartment in a high building at 6250 Bathurst St. challenged north end crews. Flames were rolling 10' out the unit's windows and even the hallway was untenable. Crews on the fire floor located a woman who had escaped to her balcony but already suffered serious injuries. She had to be brought down an aerial ladder to waiting paramedics. Another woman was also treated for serious injuries and several other residents suffered smoke inhalation. Eventually, five alarms were sounded, dozens of stressed tenants assessed and reassured and the \$500,000 fire extinguished. This was accomplished by using a Bronto to cool the outside and prevent extension upstairs while interior crews using 2.5" lines knocked down the flames.

The last major outbreak occurred on December 27 in the west end of the old city. In this case, the structures were built into the side of a hill with ground level storefronts at 1975, 1977 and 1879 Dundas St. W., which were actually the top floors, with one or two floors for processing and storage below. Heavy fire conditions greeted TFS crews and an exterior attack was mounted using three ladder pipes and a Bronto, as well as numerous lines and monitors. The vacant buildings collapsed and fire crews were hard pressed to access the blaze beneath the remains of the roof. Four alarms were sounded as relays were set up from distant hydrants and personnel were rotated through front-line positions.

No new apparatus have been put in service this year but Toronto did receive this High Capacity Foam Pumper in December. E-One built it on a Freightliner FL112 chassis, it has a 2650gpm pump and 2030 gallon foam tank. Likely in service in the spring after mechanical has checked it over and the crews are trained on it. MONTREAL AUXILIARY (PAM)

As I sit here reflecting on the year that was 2020, I find myself smiling and proud of the tasks that the Montreal Auxiliary have accomplished. For as trying as the year has been with COVID-19 lock downs, new safety directives, and isolations, I realize that our year has been busy and productive in a way that only COVID could have given us



In January 2020, we started the preparations to temporarily close the fire museum and relocate our rehab vehicles to a new location. At the same time, we were advised that our other building (station 32 in Cote-St-Paul) where we do all the work on our fleet of antique vehicles, would be closing permanently. Advised by the city that we would have to be out of that station no later than the first snow fall (November - December), we opened the doors, looked around and let out a heavy sigh wondering where and how to start and how to juggle both moves at the same time.













As a group, we pulled together and began the daunting task of sorting through objects that have been accumulating over the last ³/₄ of a century, knowing that we would soon be permanently closing the doors to a beloved building that we had called home for over 40 years. Making ruthless decisions on what was to be moved and what could be recycled, we sent a group upstairs to start boxing equipment into small plastic boxes. Realizing very quickly that tiny plastic boxes were not going to be strong enough to move fire extinguishers, engine parts, sirens, bells, nozzles, etc. we had to come up with another option and fast. Deciding on wooden crates,



approximately 2 feet x 4 feet, we set to the task of constructing each of the 40 boxes we estimated would been needed to pack, store, and move the items we would be taking with us.





Working at the museum on Friday nights, we had to move everything from the front half to other parts of the museum. All photos had to come off the walls, artifacts had to be stored and everything in the basement needed to be packed and moved out of the building, even the administrative office. As the whole station was scheduled for major renovations, we were also losing the space for our rehab vehicles and our weekly meeting place. After tense negotiations, a section of an old warehouse, located on Bellechase Ave, that is presently occupied by Montreal fire, HUSAR, and training of specialty teams, was to be renovated for our rehab vehicles and equipment. As our new location had never been used for emergency vehicles, we had to work closely with the department and the city to adapt both the inside and outside of the building to be safe and ready to receive our group.



Just as this was starting to come together, we found ourselves entering a lock down associated with the first COVID wave that swept through Montreal. Following the directive issued by the Montreal Fire department, we were forced to establish guidelines and present them to the city. With the new measures approved, we had to abandon our endeavors and rely on zoom meetings to support our

members as we all "enjoyed" forced isolation with our immediate families. Weeks later, as restrictions eased and we were able to resume our work, albeit with limited numbers and younger persons only, we started once again in earnest.

As we packed up one station, we also had to prepare another location for everything that needed to be moved. Cleaning and vacuuming 20 years of dirt and dust, scrubbing, and painting floors, pulling down old walls and putting up new ones, measuring and setting up racking, removing all traces of the previous tenants and making the space our own, there was a lot to be done and we made it happen on time !
































































Our new repair and restoration facility is now located in the same building that our rehab trucks were moved to. Negotiations were still needed to make sure we had the space required for all our antique vehicles, stock, and activities.

Coordinating the actual move of all the equipment, trucks and horse drawn vehicles, we set about organizing the moving company that was needed to transport everything. As you can imagine, doing this during a global pandemic was no easy task. Keeping physical distance and wearing face masks while minimizing the personnel needed at multiple locations required strict guidelines and timing. My least favorite part of the move came in November as we moved out the very last of the items from 32. All that was left were 2 engines......yes complete engines and a few wooden and aluminum ladders which we had accumulated over the years ranging from 8 to 36 feet long. The ladders and 2 engines were transported on a low bed truck supplied by the city garage to our new location on Bellechase.

All this was done during a year during which we still responded to over 80 fire calls. Following the new measures that were set into place our group was restricted to only 5 members per call and did not allow members over 70 years of age to respond....they were not happy, but their safety is our priority ! All special events, parades, parties, and educational activities were cancelled. This has been a trying year for everyone, but I am proud of the work my group did, the dedication, and responsibility that each member has shown throughout the year. I would like to take this time and say to the members of the PAM: thank you for not only your tremendously diligent work but also for all the support you have given each other throughout this humungous project, that is what makes our team stronger!

To everyone reading this article, I wish you and your families a healthy, safe, and prosperous new year. Stay safe and see you in Ottawa, Canada for FUN FELLOWSHIP and FIRETRUCKS !!

Hello from Southern Ontario where the 2020 fire buffing season never happened except for what individual members did on their own in their respective municipalities. However, we still managed to get our bi-monthly newsletters published on time. In mid March the Province of Ontario brought in strict emergency regulations regarding physical distancing and shuttering of all but essential businesses and services in response to the Covid-19 pandemic. All fire services immediately shut their doors to visitors. This shut down forced us to revise our plans for photo tours in 2020. Our planned tours of the Peterborough area, the city of Hamilton, cities of Kitchener & Waterloo, city of Kingston and the towns of Port Hope, Cobourg and area were all cancelled and will be re-scheduled for 2021. We also had to cancel our annual Fire Services Collectibles Show and Sale and our in person 49th Annual General Business meeting normally held on the first Saturday in November.

2021 is the 50th Anniversary of the founding of the Ontario Fire Buff Associates and we plan to celebrate by co-hosting the 2021 IFBA Convention in Ottawa in September and with a 50th Anniversary Banquet scheduled for Saturday, November 6, 2021 in Toronto, Ontario.

The Ontario Fire Buff Associates came into being after 4 Canadian fire apparatus buffs became acquainted with each other at the 1970 SPAAMFAA National Convention in Syracuse. They kept in touch and decided to form a Southern Ontario Chapter of SPAAMFAA which became the Ontario Fire Buffs Association in 1971. The club was renamed the Ontario Fire Buff Associates in 1978 after incorporation.

Objectives of the club were to collect and disseminate knowledge of the Ontario Fire Service, encourage friendship and interchange of ideas among its members, promote and maintain high standards of conduct amongst its members, encourage fire departments or individuals to maintain and restore vintage firefighting apparatus and equipment, preserve all matter relating to the history of the fire service, assist fire departments in the fields of fire prevention, fire department displays, photography or any other way requested, assist in the creation and support of a fire service museum and to publish a bi-monthly newsletter allowing members to keep abreast of fire apparatus related activities across Canada. Our present membership consists of 97 Canadians, 4 Americans and 4 citizens of the United Kingdom. Of the 97 Canadians, 82 live in Ontario, 7 in British Columbia, 2 in Alberta, 1 in Saskatchewan, 4 in Quebec and 1 in Nova Scotia. Some of our members were deeply involved in the establishment of the Canadian Firefighters Museum in Port Hope, Ontario and many of our members are also involved with or helped establish fire rehab and canteen services in their local communities, ie. the Greater Toronto Multiple Alarm Association, Box 43 in Hamilton, Box 690 in the Waterloo Region, PAM and the former Regional Niagara Fire Buff Associates.

ur bi-monthly newsletter, the "Third Alarm" provides news of club activities, apparatus deliveries, new fire stations and photos of new and antique apparatus from around the world submitted by members, subscribers, and Canadian apparatus manufacturers and distributors. Members have the option of receiving the newsletter in hard copy, electronic (digital) copy or both. Annual membership in the OFBA is \$20 with digital copy, \$28. with hard copy or \$35. with both. A one-time \$5. processing fee is charged for new members in addition to their annual dues. The print copy usually runs from 20-22 pages while the digital copy (sent directly to your inbox) averages 36 – 40 pages in full colour. Subscribers receive the digital copy only for \$15. (Cdn funds).

The following was submitted to Turnout for publication in the Fall of 2019 but somehow got lost in the changeover to the new editing team and is reprinted here for your edification.

The OFBA's 2019 buffing season came to an end on Saturday, November 2 as we held our 28th Annual Fire Services Collectibles Show in the morning followed by our 48th Annual General Business Meeting and biennial election of officers in the afternoon.

A plastic pocket calendar color coded for the 24/48 shifts is included with the full-sized calendar.




NATIONAL FIRE HERITAGE CENTER

Introduction

The National Fire Heritage Center includes the National Fire Heritage Archives, The National Fire Museum System, and the National Fire Heritage Foundation. These organizations within the Center are 501 (c)3 nonprofit organizations all working to preserve the history of "fire in America". Our preservation efforts not only include firefighting, but also fire prevention, fire protection engineering, fire equipment manufacturing, and any discipline associated with fire protection.

We support researchers, historians, individuals, and organizations interested in fire protection. This includes municipal and rural firefighting, aviation fire fighting, wildland firefighting, firefighting in the military, design and engineering, architecture, fire training and academic programs, rail and utilities, equipment manufacturing, regulations and standards, fire equipment distributors, and any other area of fire protection. Prior to the establishment of the NFHC, there was no centralized, coordinated archival of fire protection in the United States. Much of the written history of "fire in America" is challenging to locate and sadly, much information is permanently lost.

The National Fire Heritage Center is the result of a study done by the U.S. Fire Administration where it identified that a "need to collect, preserve, and provide access to the historical records of the fire service/fire protection disciplines in the United States." In spiteof the study, the project never aquired government funding. However, Chief Ronny Coleman of California and several other interested fire protection experts took it upon themselves to create an independent non-profit organization called the National Fire Heritage Center. The organization has expanded from the original mission to protect perishable items, to include three dimensional objects and other important fire protection materials. The Center also is home for the Fire Service Hall of Legends, and the Benjamin Franklin Fire Writer's Award. Today, the National Fire Heritage Center is a vibrant organization supported by private donations and grants. The Archive is growing so rapidly, that the Board of Trustees has been given the task of finding a new home - from which the NFHC will continue to persevere the history the American Fire Service for generations to come.
